RIGHT OF WAY DEED FOR PERMANENT EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of FIVE HUNDRED AND NO/100 (\$500.00) dollar(s) cash in hand paid, the receipt of which is hereby acknowledged, as I (we), the undersigned grantor(s), Tanya Wilson, an unmarried woman, have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County, a political subdivision of the State of Alabama, a permanent easement and right of way including all right, title and interest in and to all timber growing or at any time located within the right of way and easement limits, upon the land hereinafter described, together with the right to locate or relocate utilities, and to enter upon such described land and grade, level, fill, drain, pave, build, maintain, repair, and rebuild a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary, on, over and across such right of way easement. The easement and right of way hereby granted is more particularly located and described as follows:

Right-of-Way Deed:

A part of the NW ¼ of the SW ¼, Section 19, Township 18S, Range 2E, identified as Tract No. 8 in Shelby County Alabama and being more fully described as follows:

Tract #8 - Parcel #1 of #1:

COMMENCE at a Vertical Rail Road Rail found on the Northeast Right-of-Way jog of the Norfolk Southern Rail Road, said being labeled as Station 21895+00, on a Right-of Way map for Central of Georgia Railway Resurvey; thence run North 44° 32' 18" West along the Northeast Right-of-Way of the Norfolk Southern Rail Road for a distance of 262.30 feet to the **POINT OF BEGINNING** of the following described Right-of-Way taking, that is a point on the South line of the Northwest Quarter of the Southwest Quarter of Section 19, Township 18 South, Range 2 East, said point being 34.71 feet left of and at a right angle to the centerline of May Street at Station 87+47.86; thence leaving the Northeast Right-of-Way of the Norfolk Southern Rail Road run North 45° 08' 27" East along the Southeast Right-of-Way of May Street for a distance of 25.00 feet to a point, that is point 34.62 feet left of and at a right angle to the centerline of May Street at Station 87+22.86; thence leaving the East Right-of-Way of May Street run South 00° 18' 04" West for a distance of 17.53 feet to a point, that is point 47.03 feet left of and at a right angle to the centerline of May Street at Station 87+35.25; thence run South 89° 40' 21" West for a distance of 17.63 feet to the POINT OF BEGINNING, that is point 34.71 feet left of and at a right angle to the centerline of May Street at Station 87+47.86;

said Right-of-Way Taking containing 155 Square Feet (0.01 acres) more or less;

said Right-of-Way taking is shown on the right of way map of record in the Highway Department of Shelby County Alabama a copy of which is also deposited in the office of the Judge of Probate as an aid to persons and entities interested therein and as shown on the Property Sketch attached hereto and made a part hereof.

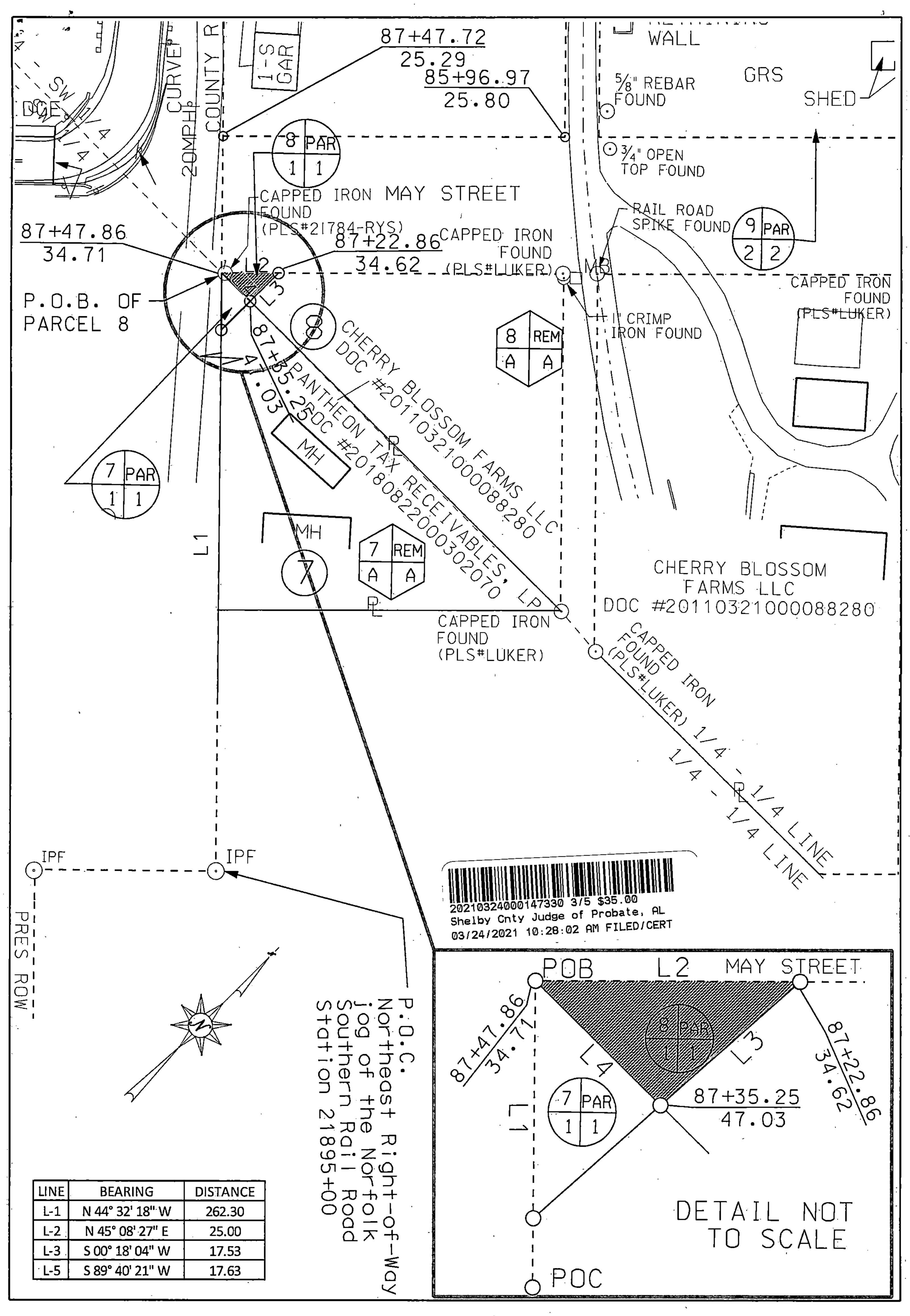
TO HAVE AND TO HOLD, the said easement and right of way including all right, title, and interest in and to such timber aforementioned unto Shelby County, a political subdivision of the State of Alabama, and unto its successors and assigns forever.

And the said grantor(s) hereby covenant(s) with Shelby County, a political subdivision of the State of Alabama, that I (we) am (are) lawfully seized and possessed of the afore-described tract or parcel of land; that I (we) have a good and lawful right to sell and convey it; that it is free from all encumbrances; and that I (we) will warrant and forever defend the title and quiet possession thereto against the lawful claims of all persons whomsoever.

As a further consideration for the payment of the purchase price, above stated, I (we) hereby release Shelby County, a political subdivision of the State of Alabama, its employees and officials, from all claims for damage, from whatsoever cause, present or prospective, incidental or consequential, to the exercise of any of the rights herein granted.

The grantor hereby grants permission, with right of ingress to and egress from, grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right of way.
