KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of NINE HUNDRED AND NO/100 (\$900.00) dollar(s) cash in hand paid, the receipt of which is hereby acknowledged, as I (we), the undersigned grantor(s), Martha Webster, an unmarried woman, have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County, a political subdivision of the State of Alabama, a permanent easement and right of way including all right, title and interest in and to all timber growing or at any time located within the right of way and easement limits, upon the land hereinafter described, together with the right to locate or relocate utilities, and to enter upon such described land and grade, level, fill, drain, pave, build, maintain, repair, and rebuild a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary, on, over and across such right of way easement. The easement and right of way hereby granted is more particularly located and described as follows:

Right-of-Way Deed:

A part of the NW ¼ of the SW ¼, Section 19, Township 18S, Range 2E, identified as Tract No. 12 in Shelby County Alabama and being more fully described as follows:

Tract #12 - Parcel #1 of #1:

COMMENCE at a Vertical Rail Road Rail found on the Northeast Right-of-Way jog of the Norfolk Southern Rail Road, said being labeled as Station 21895+00, on a Right-of Way map for Central of Georgia Railway Resurvey; thence N 44° 32′ 18″ W along the Northeast Right-of-Way of Norfolk Southern Rail Road for a distance of 262.30 feet to a point on the South line of the Northwest Quarter of the Southwest Quarter of Section 19, Township 18 South, Range 2 East; thence North 44° 32′ 18″ West along the Northeast Right-of-Way of Norfolk Southern Rail Road for a distance of 363.80 feet to a point; thence leaving the Northeast Right-of-Way of Norfolk Southern Rail Road run North 45° 27′ 42″ East for a distance of 526.54 feet to the POINT OF BEGINNING, said point being on Northwest Right-of-Way of County Road 55, that is point 26.38 feet left of and at a right angle to the project centerline at Station 22+26.01;

thence leaving the Northwest Right-of-Way of County Road 55 run North 42° 55' 34" West for a distance of 10.00 feet to a point, that is point 36.28 feet left of and at a right angle to the project centerline at Station 22+27.35; thence run North 46° 03' 43" East for a distance of 91.95 feet to a point, that is point 29.25 feet left of and at a right angle to the project centerline

at Station 23+16.23; thence run South 45° 23' 07" East for a distance of 10.00 feet to a point on the Northwest Right-of-Way of County Road 55, that is point 19.25 feet left of and at a right angle to the project centerline at Station 23+16.15; thence run South 46° 03' 43" West along the Northwest Right-of-Way of County Road 55 for a distance of 92.38 feet to the **POINT OF BEGINNING**, that is point 26.38 feet left of and at a right angle to the project centerline at Station 22+26.01; said Right-of-Way Taking containing 922 Square Feet (0.02 acres) more or less;

said Right-of-Way taking is shown on the right of way map of record in the Highway Department of Shelby County Alabama a copy of which is also deposited in the office of the Judge of Probate as an aid to persons and entities interested therein and as shown on the Property Sketch attached hereto and made a part hereof.

TO HAVE AND TO HOLD, the said easement and right of way including all right, title, and interest in and to such timber aforementioned unto Shelby County, a political subdivision of the State of Alabama, and unto its successors and assigns forever.

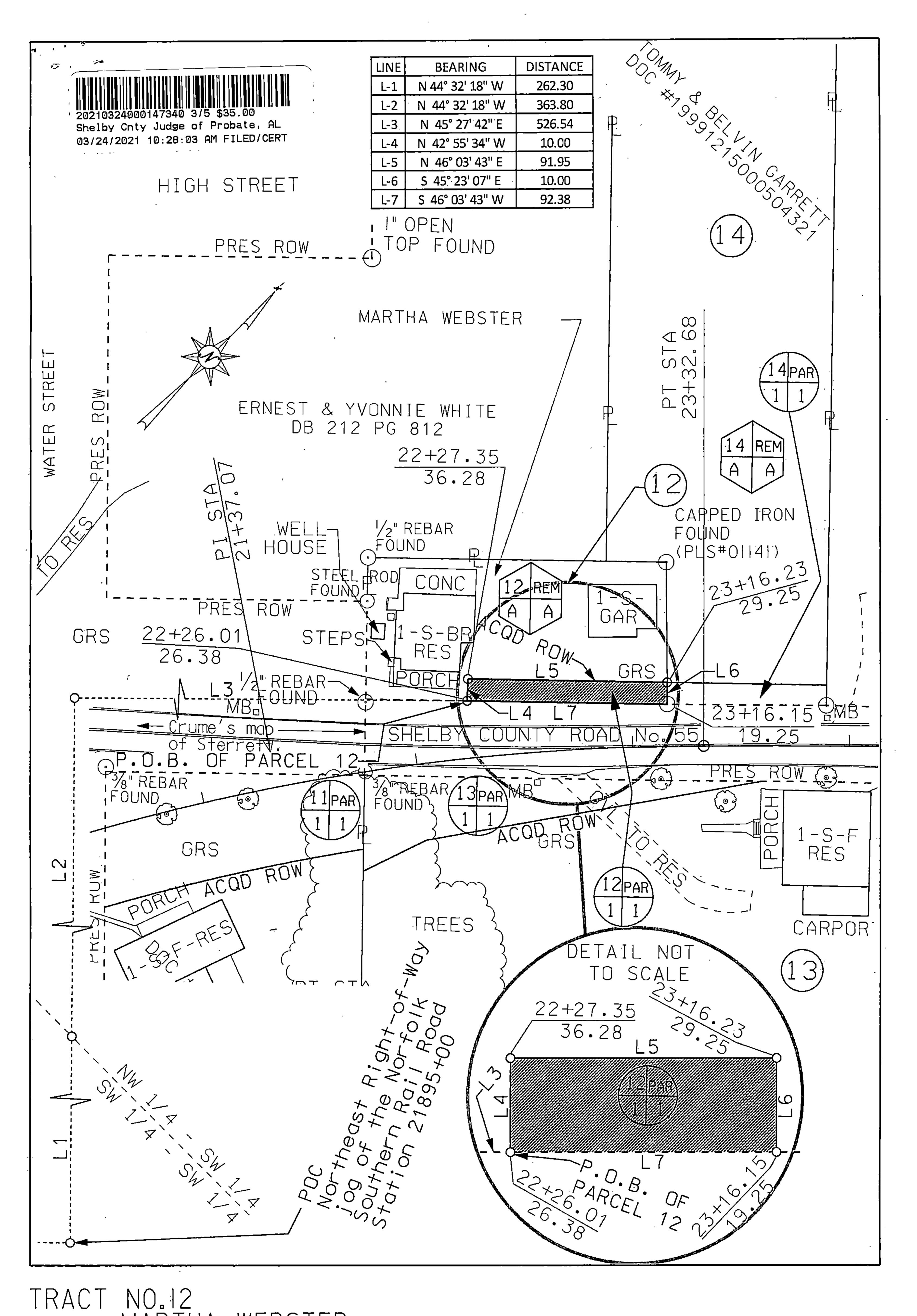
