1. That my name is James F. Willis, that I am over the age of twenty-one (21) years, I have personal knowledge of the information contained herein, and competent to execute this affidavit.





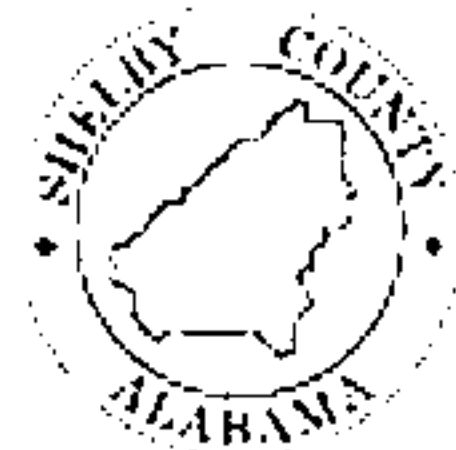
