Know All Men by These Presents: That in consideration of **One Hundred Eighty-Nine Thousand Nine Hundred and 00/100 Dollars (\$189,900.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **ANDREW J. SHEARS and BRITTNEY Z. SHEARS, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **ZOLLIE D. HEARTSILL and CATHERINE S. HEARTSILL** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

To Have and to Hold to the said Grantees, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one Grantee herein survives the other, the entire interest in fee simple shall pass to the surviving Grantee, and, if one does not survive the other, then the heirs and assigns of the Grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with said Grantee, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.


