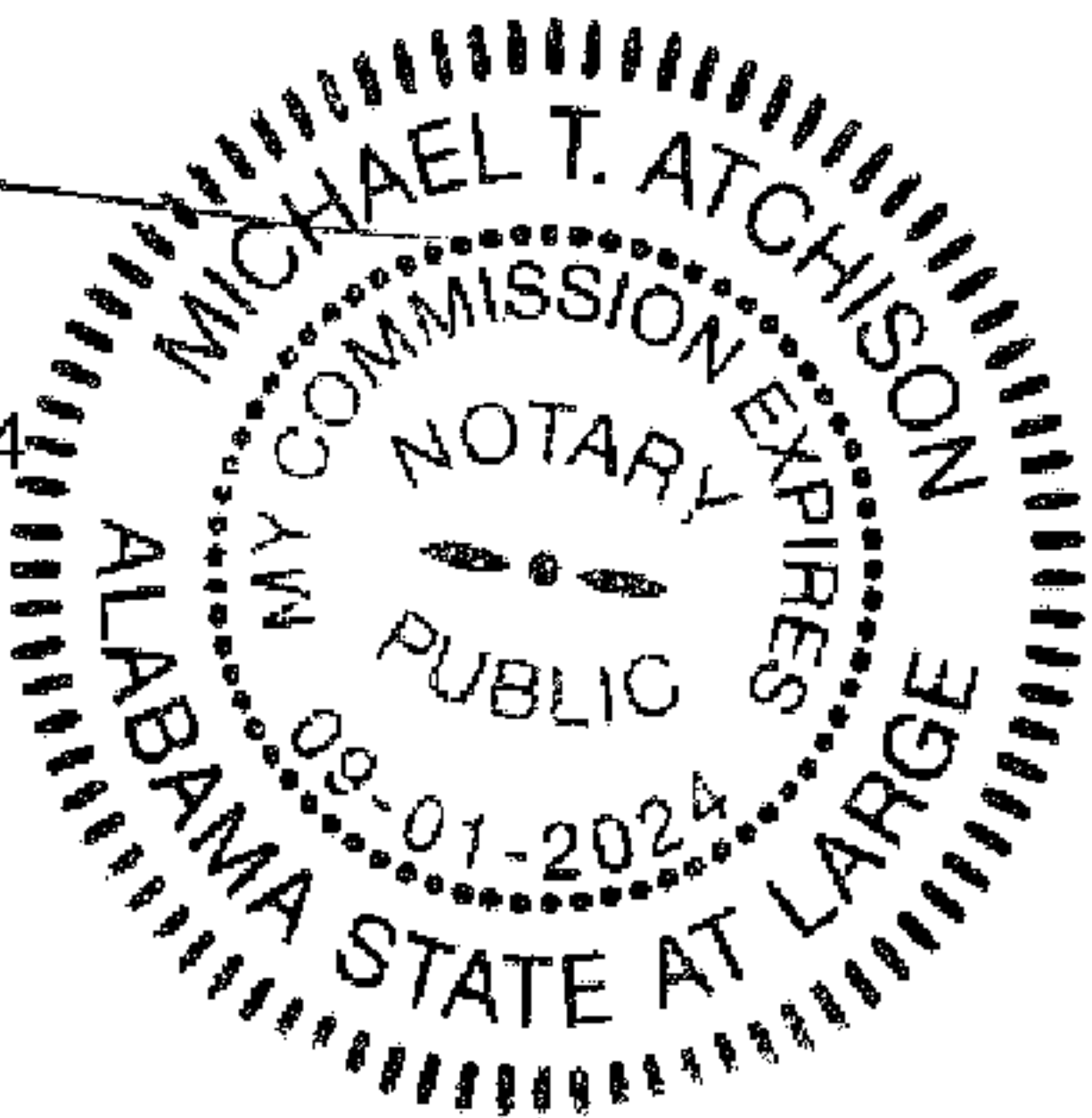


EXHIBIT "A"
LEGAL DESCRIPTION

Parcel 1:

Commence at the Northwest corner of the SE 1/4 of the NE 1/4, Section 1, Township 21 South, Range 1 East; thence run East along the North line of said 1/4-1/4 Section a distance of 153.23 feet; thence turn an angle of 90 degrees 12 minutes 43 seconds to the right and run a distance of 77.66 feet; thence turn an angle of 89 degrees 13 minutes 56 seconds to the right and run a distance of 154.95 feet to the East line of a paved street; thence turn an angle of 91 degrees 59 minutes 45 seconds to the right and run along said paved street a distance of 79.19 feet to the point of beginning. Situated in the SE 1/4 of the NE 1/4 of Section 1, Township 21 South, Range 1 East, Shelby County, Alabama.

Also, commence at the Northwest corner of the SE 1/4 of the NE 1/4, Section 1, Township 21 South, Range 1 East, being a buggy axle found; thence run East along the North line of said 1/4-1/4 for 153.23 feet to a pipe found; thence turn a deflection angle of 90 degrees 12 minutes 43 seconds to the right and run 77.66 feet to the point of beginning of the parcel herein described; thence continue along the last described course for 34.40 feet to a #5 capped iron set; thence turn a deflection angle of 81 degrees 12 minutes 15 seconds to the right and run 88.13 feet to a #5 capped iron set; thence turn a deflection angle of 8 degrees 12 minutes 45 seconds to the right and run 68.83 feet to a point, being a hole in concrete pavement; thence turn a deflection angle of 91 degrees 48 minutes 41 seconds to the right and run 46.51 feet to a point; thence turn a deflection angle of 88 degrees 00 minutes 15 seconds to the right and run 154.94 feet to the point of beginning. Said parcel is in the SE 1/4 of NE 1/4, Section 1, Township 21 South Range 1 East.
