


Subject to a third-party mortgage in the amount of \$524,900.00 executed and recorded simultaneously herewith.

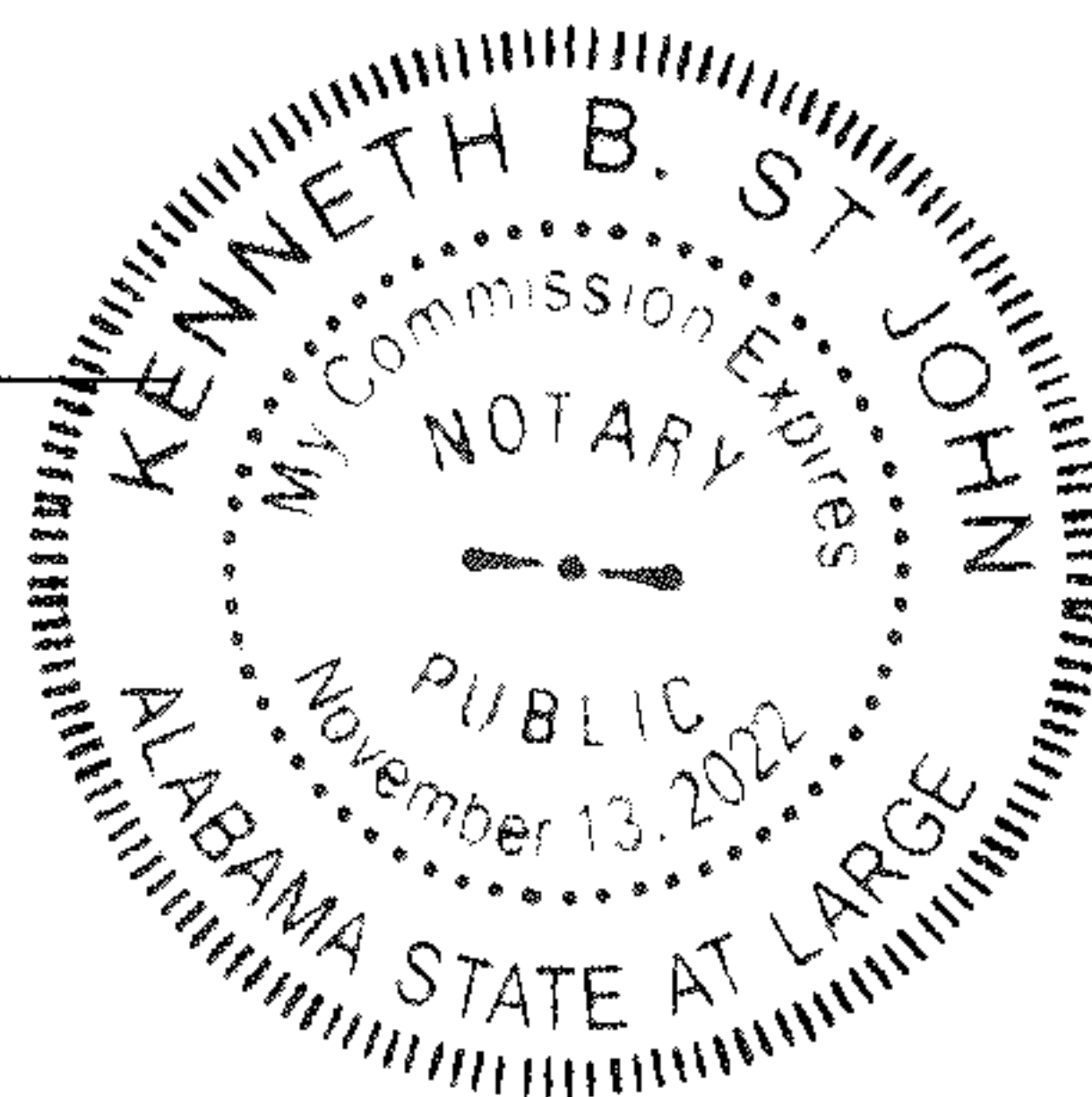

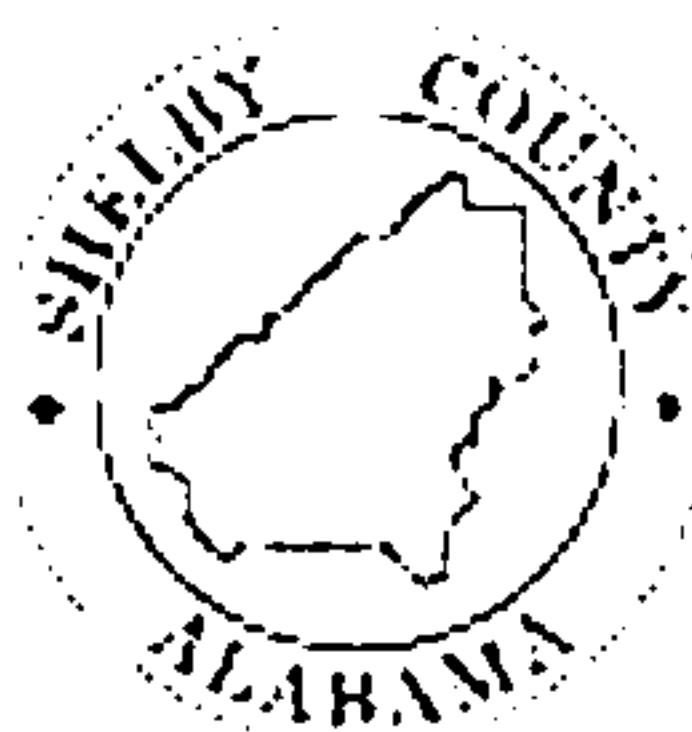
