Shelby County, Alabama, to wit:

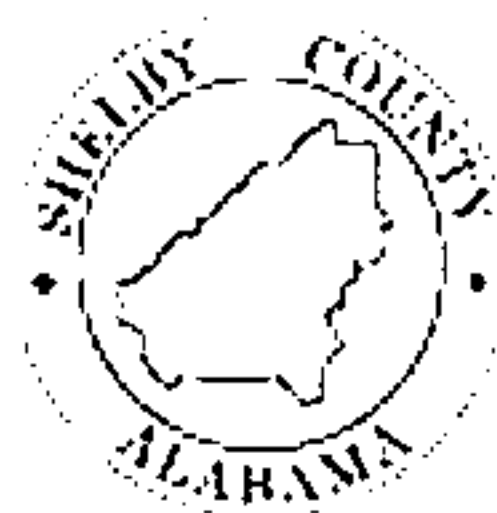
Lot 320, according to the Survey of Willow Oaks, as recorded in
