This Power of Attorney shall not be affected by my disability, incompetency, or incapacity.

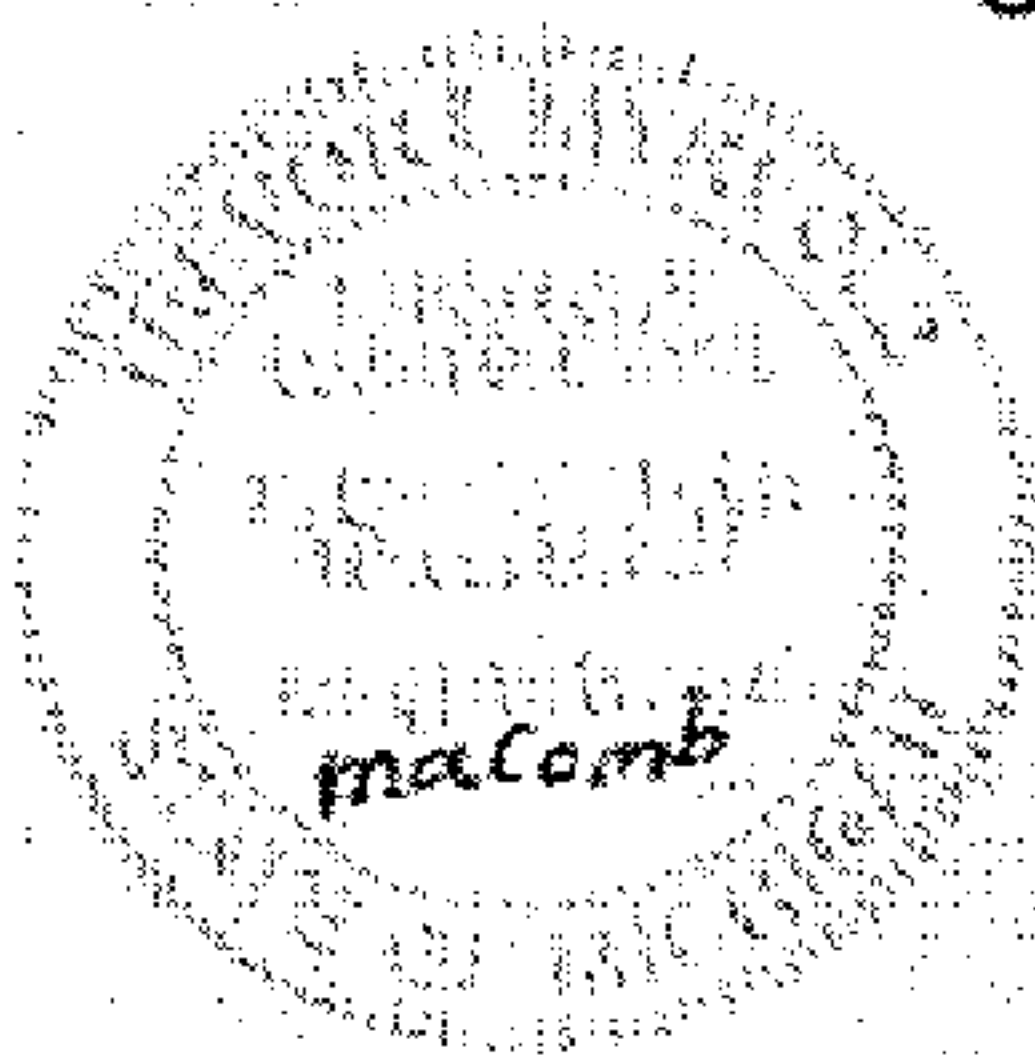



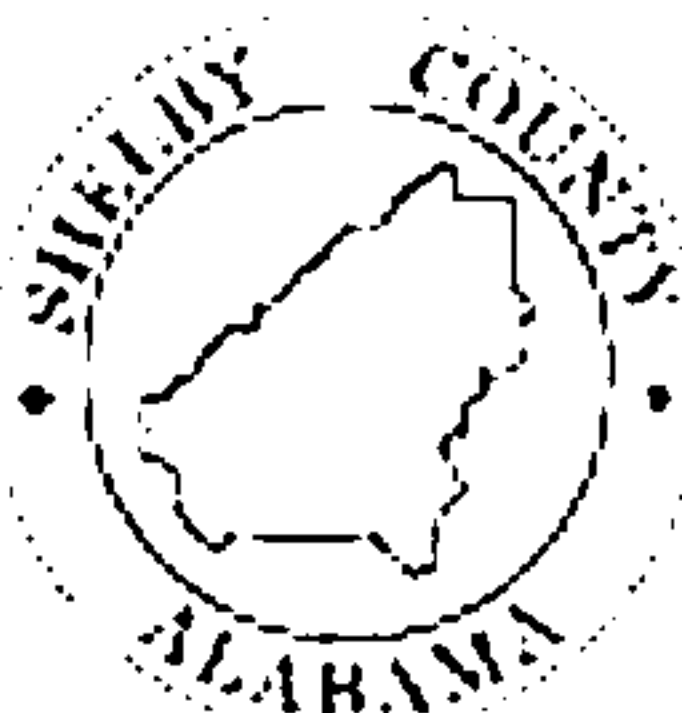
