2. Easements, restrictions, reservations and conditions of record.

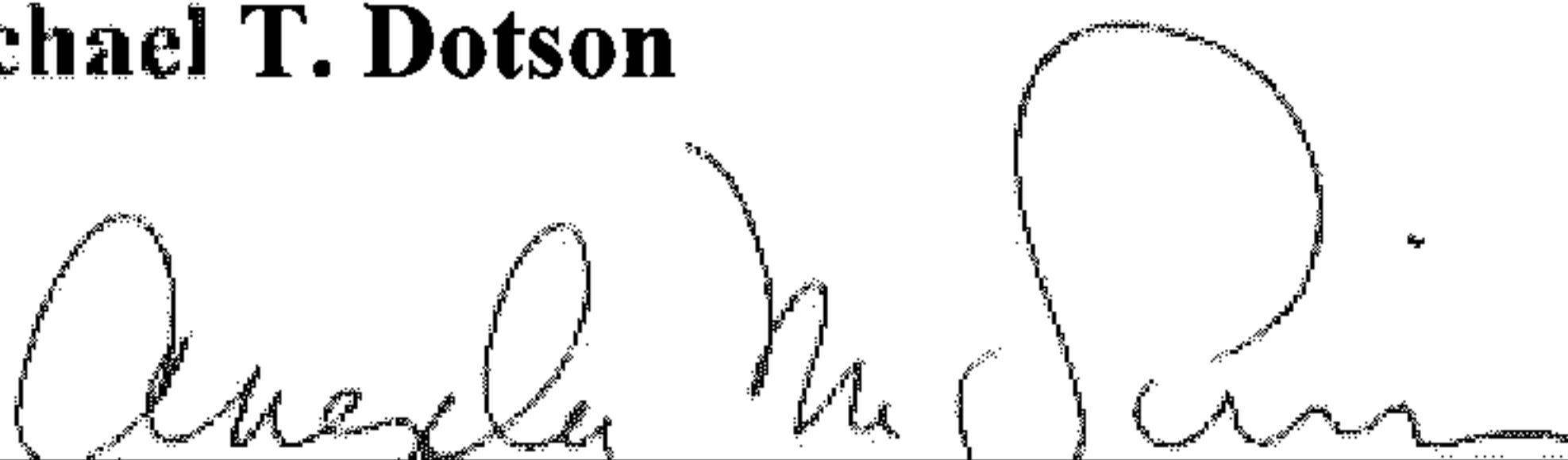

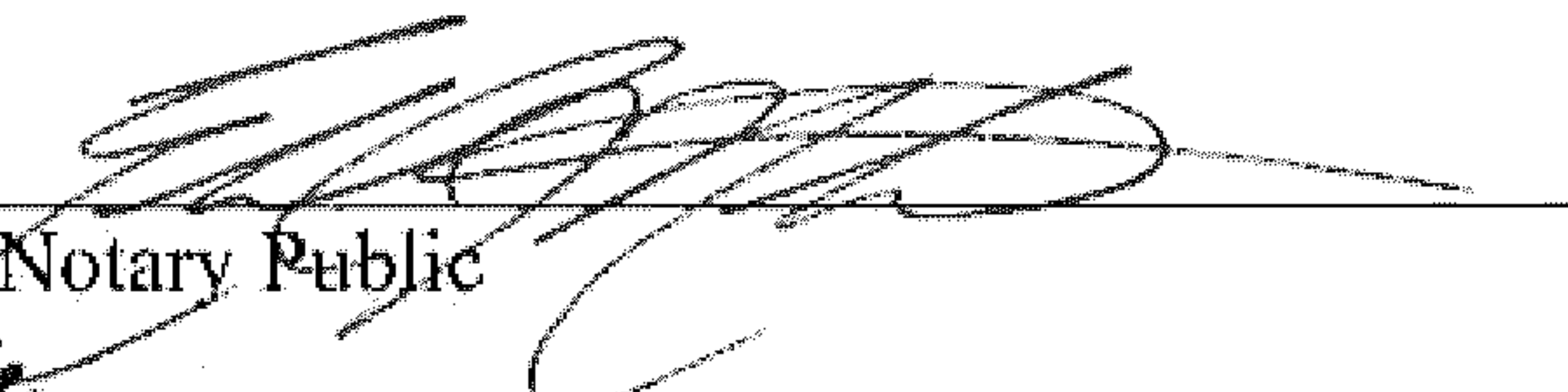

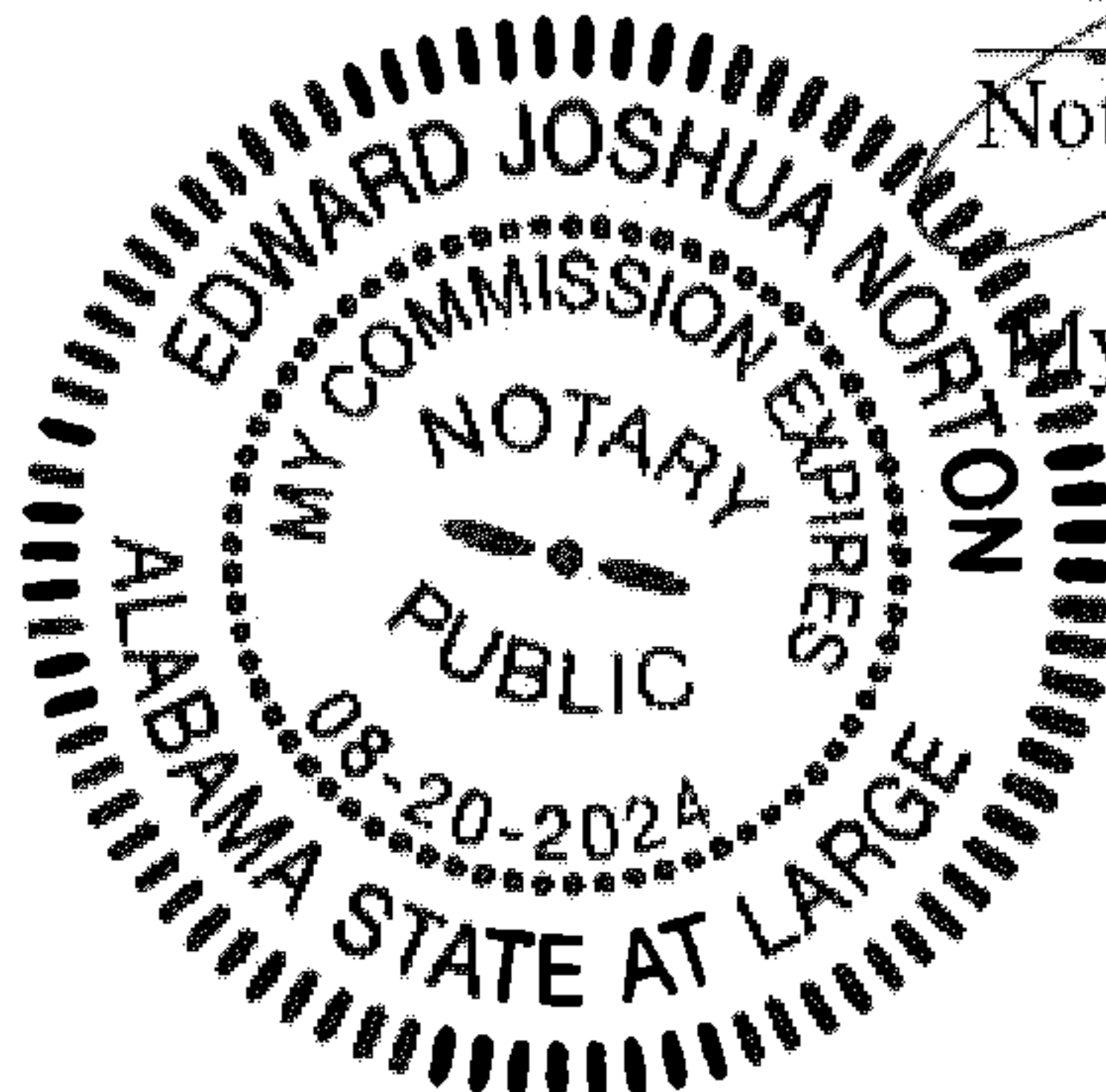
