TAYLOR WOLFE AND MOLLY M. WOLFE, TRUSTEES OR THEIR SUCCESSORS IN TRUST; UNDER THE WOLFE LIVING TRUST, DATED APRIL 7, 2021, AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more); the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 1, Block 6, according to the Amended Plat of Woodford, a subdivision of Inverness, as recorded in Map Book 8, Pages 51 A-D, in the Office of the Judge of Probate of Shelby County, Alabama.

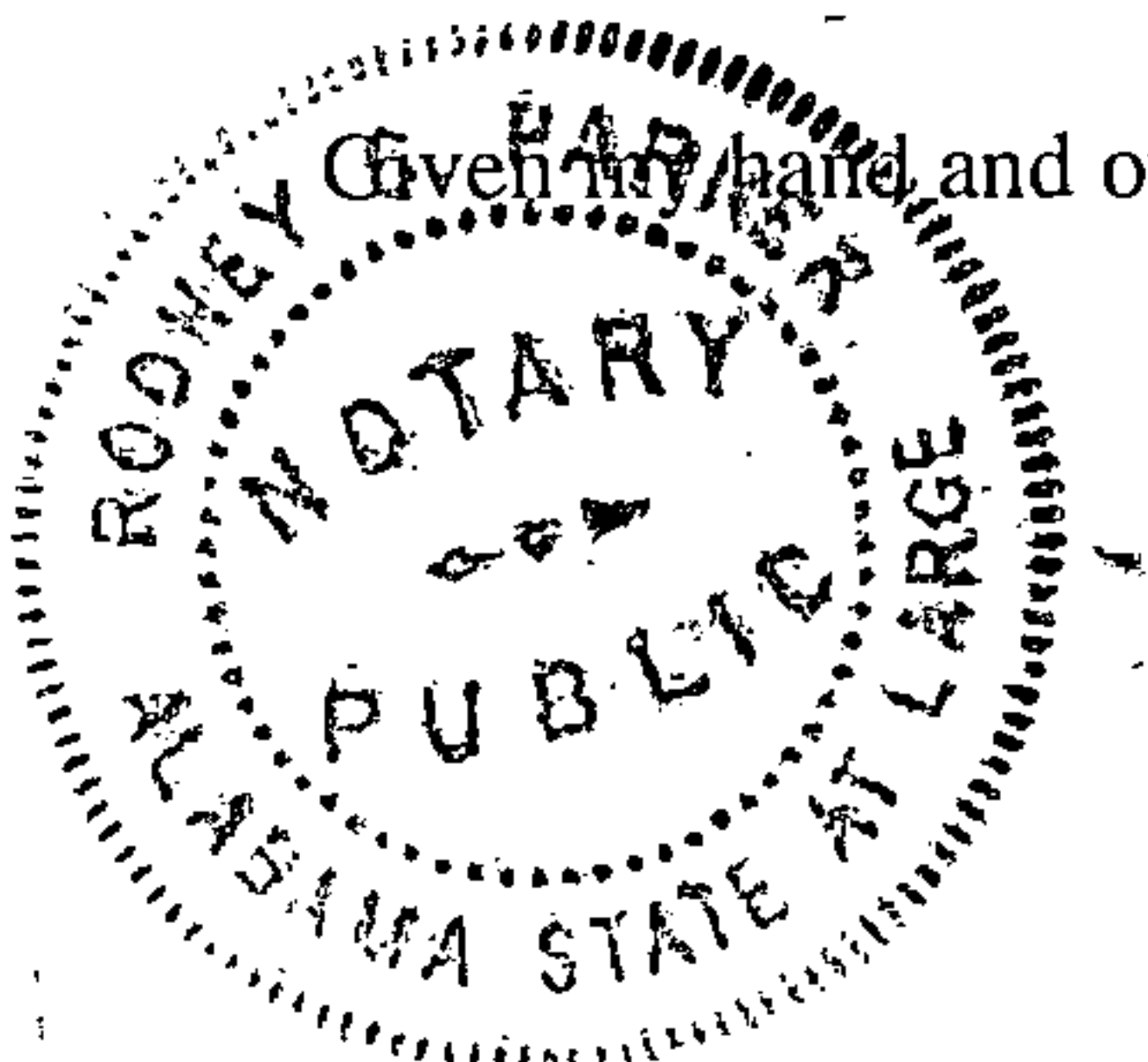
