Subordination Agreement

THIS AGREEMENT is made and entered into on this 26th day of March, 2021, by AmSouth Bank (Hereinafter referred to as "Regions Bank") in favor of Fairway Independent Mortgage Corp, its successors and/or assigns (hereinafter referred to as "Lender").

RECITALS

Regions Bank loaned to William V Powell Jr and Claudia B Powell aka Claudia Brantley (the "Borrower", whether one or more) the sum of \$13,500.00 . Such loan is evidenced by a note dated 10/31/2005, executed by Borrower in favor of Regions Bank, which note is secured by a mortgage, deed of trust, security deed, to secure debt, or other security agreement recorded 11/14/2005, Instrument # 20051114000594680 in the public records of Shelby County, AL (the "Regions Mortgage"). By its acceptance of this agreement, the borrower agrees to pay the subordination Fee set out in the Regions Subordination Request Form.
