

<u>JUDGMENT</u>

This matter came before the Court on the Motion for Default Judgment (<u>Docket</u> #10) filed by the plaintiff, André M. Toffel, Trustee.

- 1. The Complaint in this matter was filed on May 15, 2020.
- 2. The Summons and Complaint, per the file, were served on defendant, ROC Funding Group, LLC, on May 19, 2020.
- 3. ROC Funding Group, LLC, has not responded to the Complaint in this matter.
- 4. On July 6, 2020, the plaintiff, André M. Toffel, Trustee ("Toffel"), filed a application for entry of default.
- 5. On July 8, 2020, the Clerk entered a default.
- 6. Toffel filed a Motion for Default Judgment (<u>Docket #10</u>) supported by the Affidavit of Charlene A. Ryan.

Based on the Complaint and the Affidavit of Charlene A. Ryan, attached to the Motion for Default Judgment, and the Motion for Default Judgment, the Court makes the following findings of facts and conclusions of law.

FACTS

- 1. There is a certain mortgage from Mark Anthony Ryan, Jr. (debtor in this case), to ROC Funding Group, LLC, dated August 22, 2019 and attached to the Complaint in this matter as Exhibit B ("Mortgage").
- 2. The Mortgage was recorded as Instrument #20190906000329940 in the Probate Court of Shelby County, Alabama on September 6, 2019.
- 3. At the time of the execution of the Mortgage and the time of the filing of the Mortgage as outlined above, the debtor, Mark Anthony Ryan, Jr., was married to Charlene A. Ryan.
- 4. At all times between the time prior to and subsequent to the signing and filing of the Mortgage as outlined above, the property described in the Mortgage ("Property") was the homestead of Mark Anthony Ryan, Jr., and Charlene A. Ryan.
- 5. Charlene A. Ryan did not execute acquiesce or otherwise consent to the Mortgage.

CONCLUSIONS OF LAW

- 1. Pursuant to Code of Alabama 6-10-3 the Mortgage is void as being on the homestead and not being assented to or signed by the spouse of the debtor. The Mortgage being on the homestead of Mark A. Ryan, Jr., and Charlene A. Ryan.
- 2. As a matter of law, based upon the above, the Mortgage is void and is of no effect.
- 3. An order consistent with this judgment shall be entered simultaneously by this Court.
