In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- As of October 1, 2020, the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$90,781.52, consisting of the unpaid amount(s) loaned to Borrower by Lender plus any interest and other amounts capitalized.


