WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVORS

KNOW ALL MEN BY THESE PRESENTS: That in consideration Eight Hundred seventy Five Thousand and 00/100 Dollars (\$875,000.00) and other good and valuable considerations, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by Grantees herein, the receipt whereof is acknowledged, We, Sung Ho Sim and wife, Kyung Suk Youn and Ryan Eusun Sim, unmarried Grantor (herein referred to as Grantor, whether one or more) whose mailing address is 314 Highland View Drive, Birmingham, Alabama 35242, grant, bargain, sell and convey unto Stephanie R. Yates and Stephen E. Mitchell (herein referred to as Grantees) whose mailing address is 314 Highland View Drive, Birmingham, Alabama 35242, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, the address of which is 314 Highland View Drive, Birmingham, Alabama 35242, to-wit:

See Exhibit A attached hereto and incorporated by reference herein for legal description.

SUBJECT TO: (1) Taxes due in the year 2021 and thereafter; (2) Easements, restrictions, and rights-of-way of record; (3) Mineral and mining rights not owned by the Grantor, and (4) assessments due Shelby County Fire, Library and HOA dues.

\$787,500.00 of the consideration recited herein was derived from a mortgage loan closed simultaneously with the delivery of this deed.

The Grantor Sung Ho Sim is the surviving grantee in that certain deed recorded in Inst # 20040728000419430. Probate Office of Shelby county, Alabama, the other grantee, Su Yon Sim A/K/A Su Ok Linton A/K/A Su Ok Sim having died on the 27 day of December, 2014.
