Hill, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Jason R. 

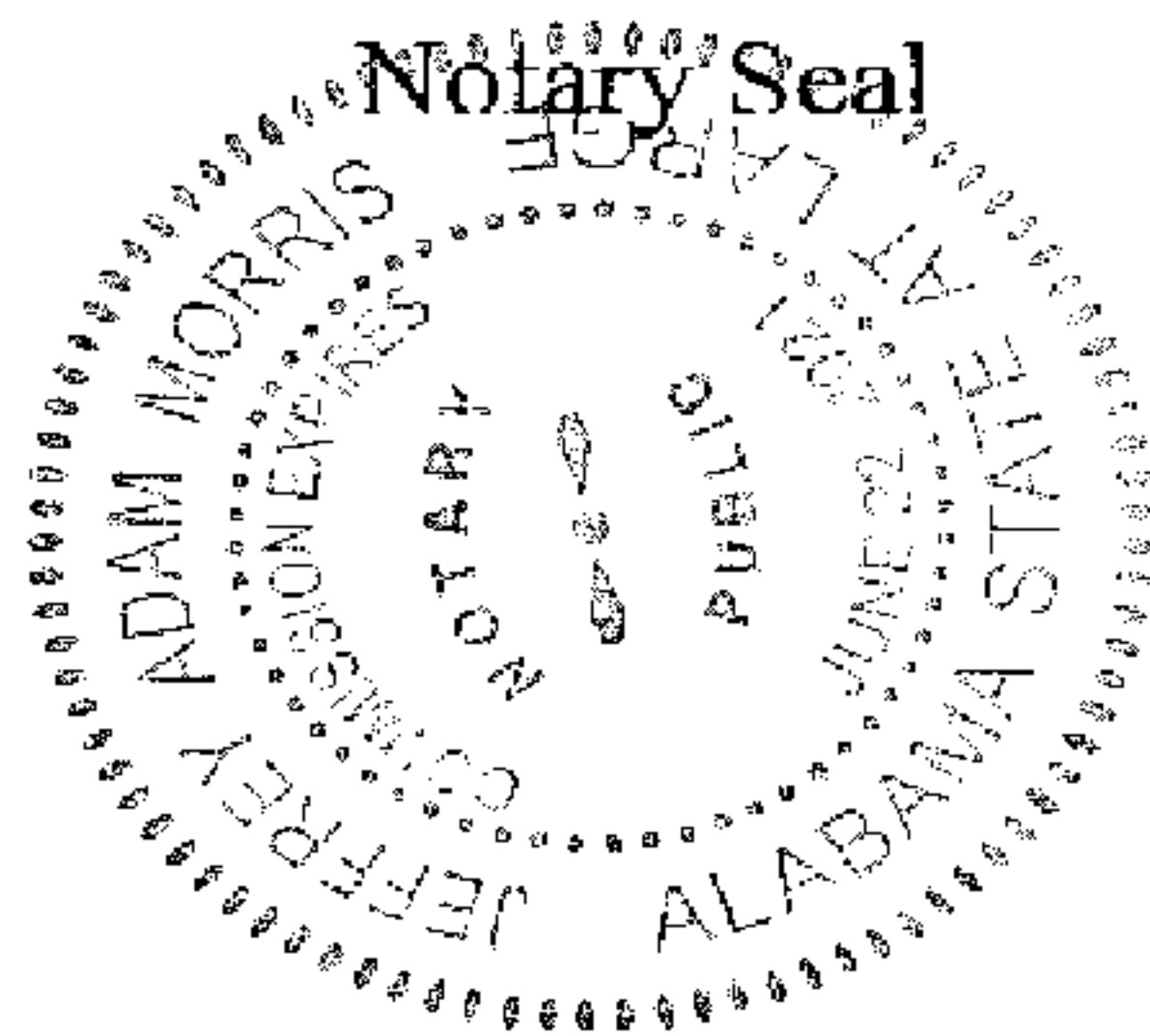
