WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Three Hundred Ninetty Seven Thousand and 00/100 Dollars (\$397,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Caleb Howard Hayden and Gabrielle Patrice Spurrell

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 85, according to the Amended Map of Hickory Ridge, as recorded in Map Book 11, page 79, in the Probate Office of Shelby County, Alabama.

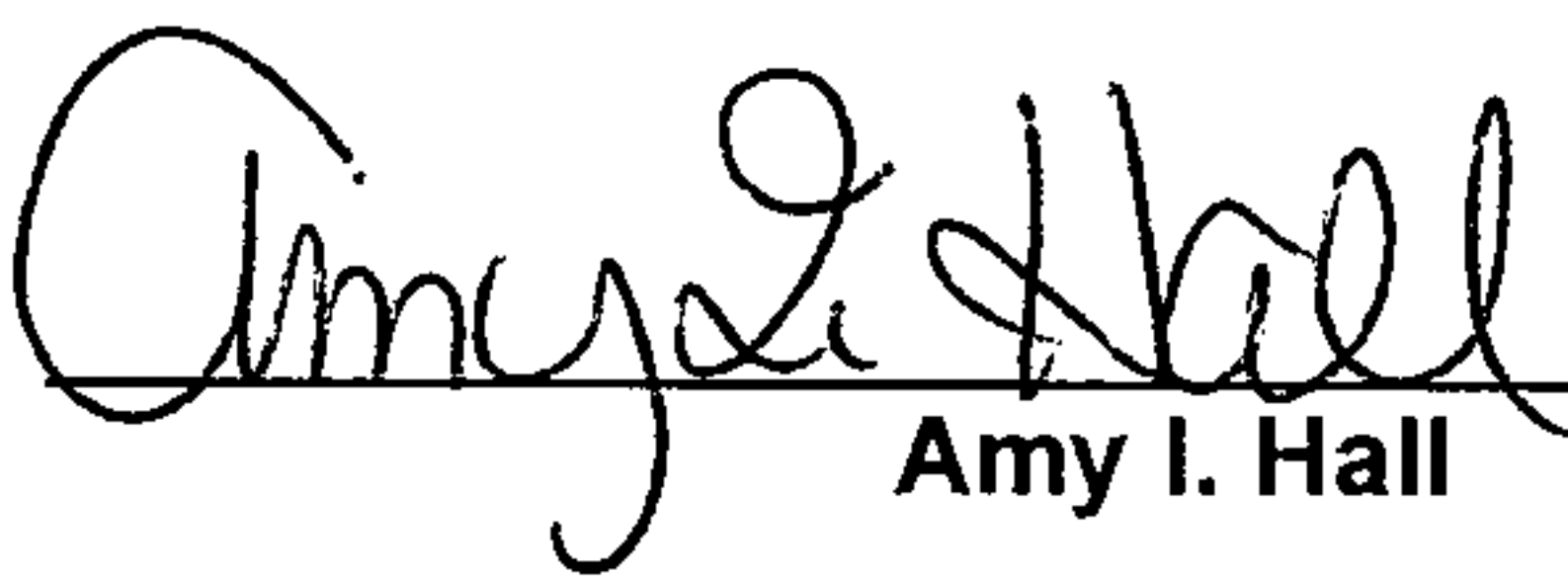
\$377,150.00 of the proceeds come from a mortgage recorded simultaneously herewith.

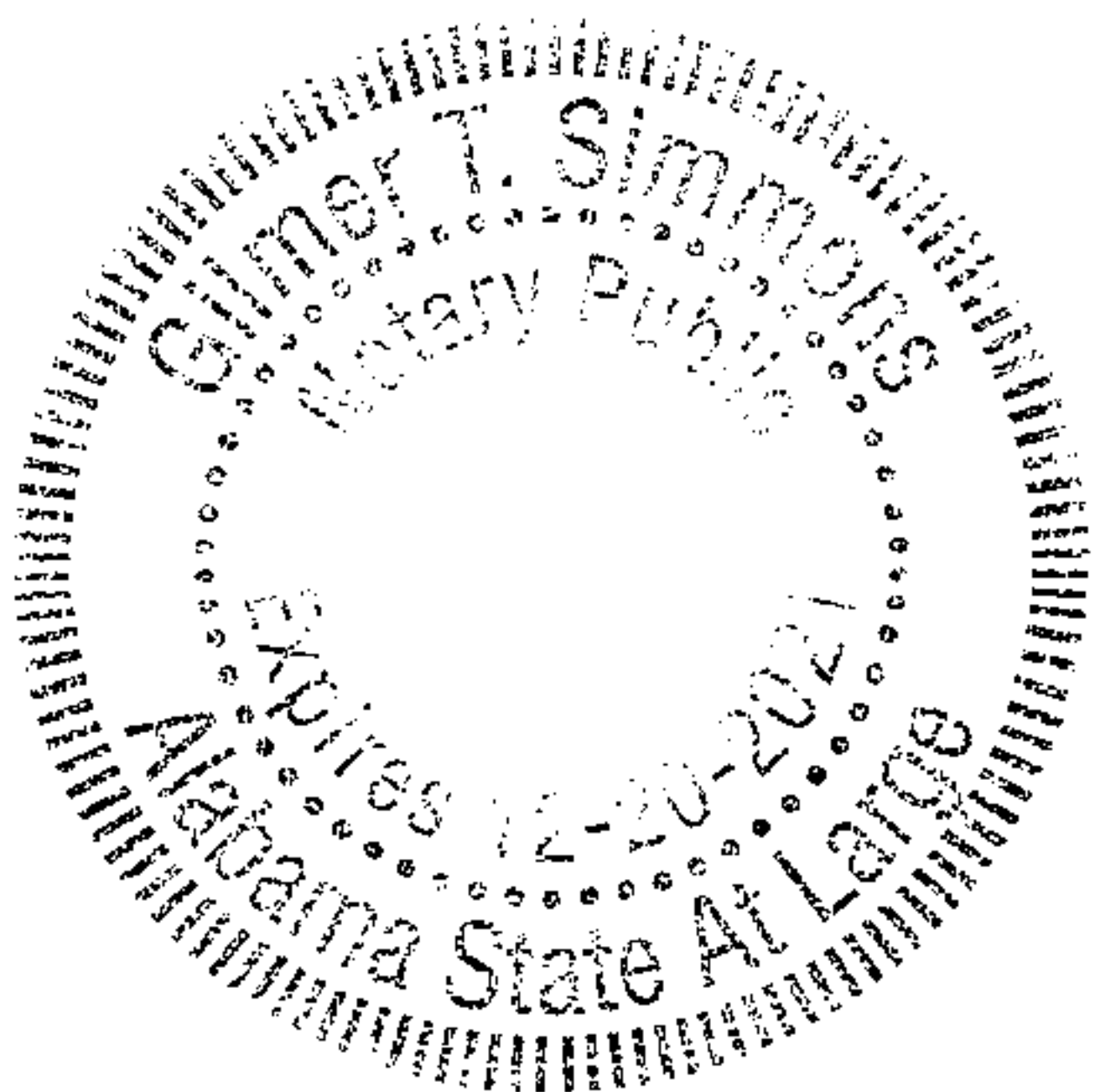
