TO HAVE AND TO HOLD to the said GRANTEE together with every contingent remainder and right of reversion.

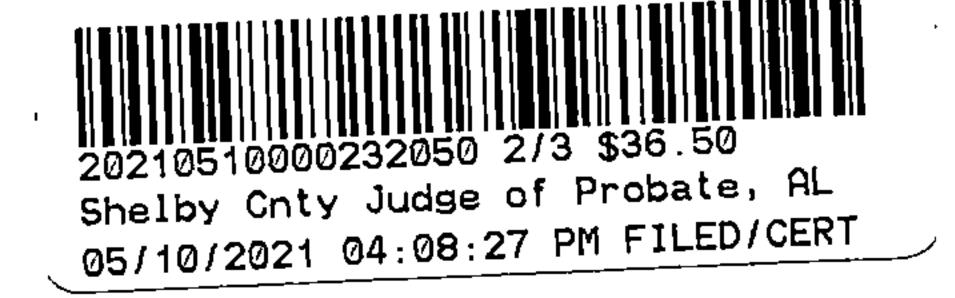
