

DURABLE SPECIFIC POWER OF ATTORNEY

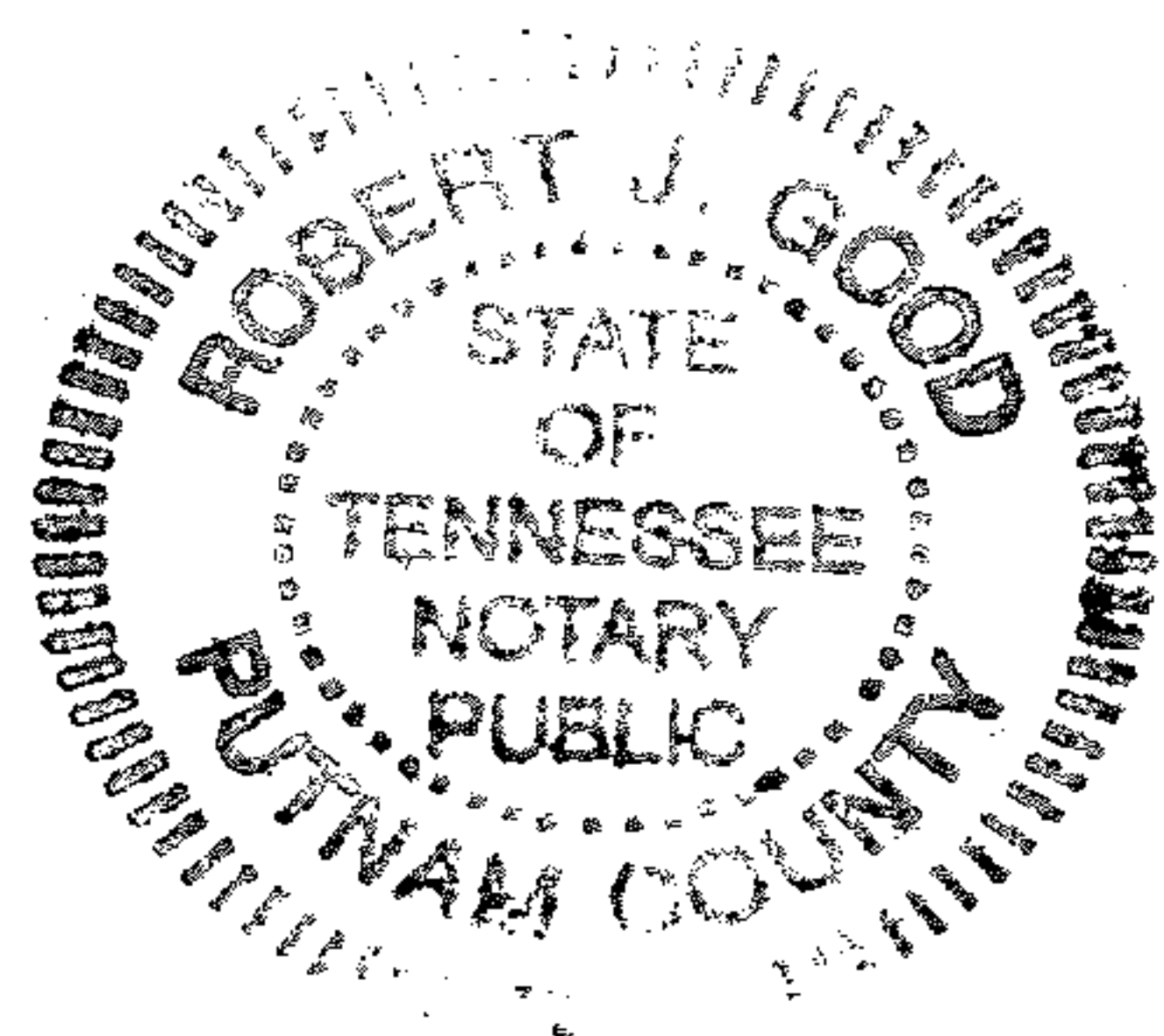
