WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Three Hundred Three Thousand and 00/100 Dollars (\$303,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Connie Ashley Williams, an unmarried person

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Daniel R. Hodgdon and Beverly A. Hodgdon and Christopher Bourbeau and Katie Bourbeau

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 44, according to the Survey of Shelby Forest Estates, Second Sector, as recorded in Map Book 23, Pages 24 A & B, in the Probate Office of Shelby County, Alabama.

\$221,400.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) - 2021 ad valorem taxes not yet due and payable;
(2) - all mineral and mining rights not owned by the Grantor; and
(3) - all easements, rights-of-way, restrictions, covenants and encumbrances of record.

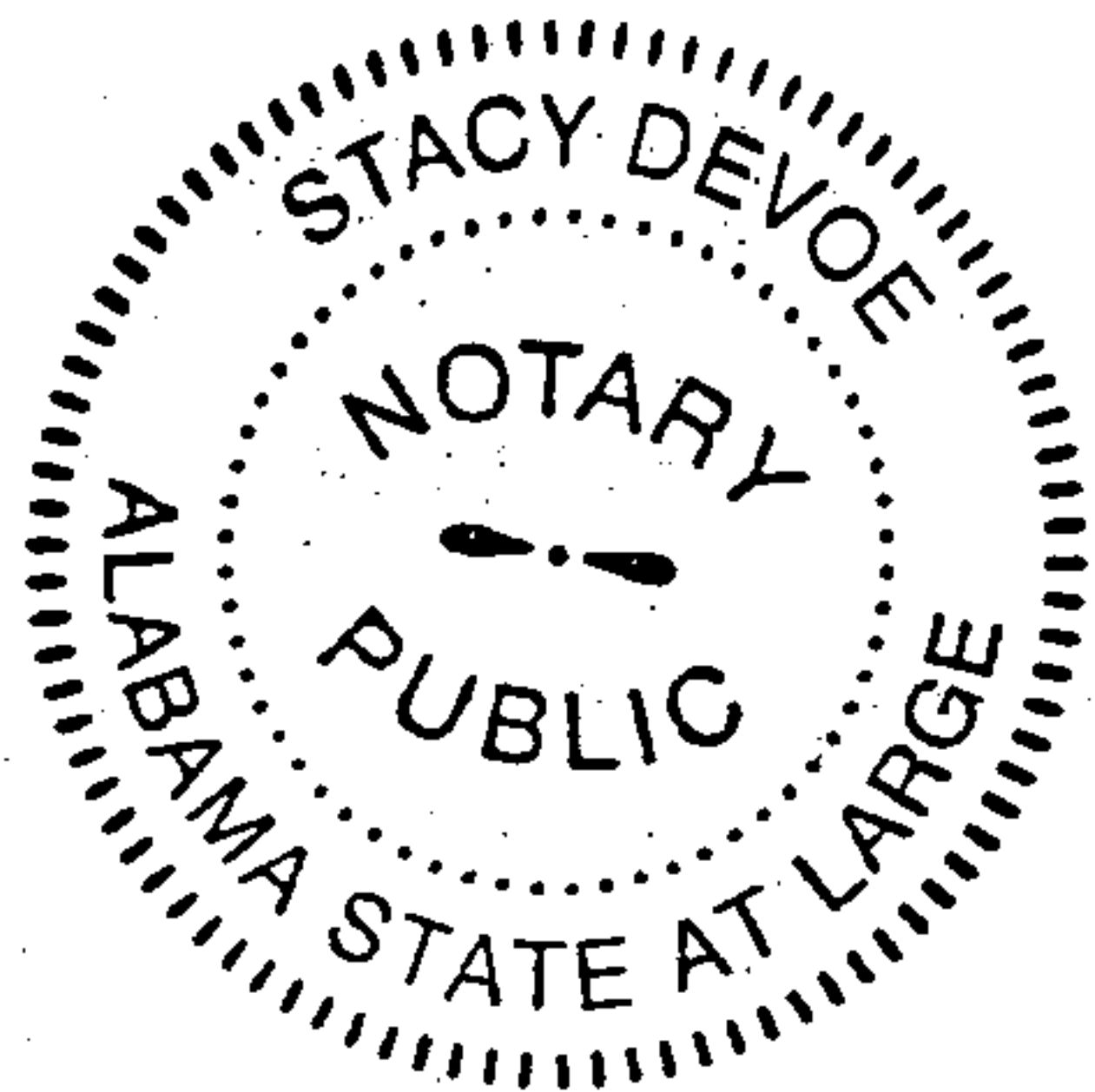
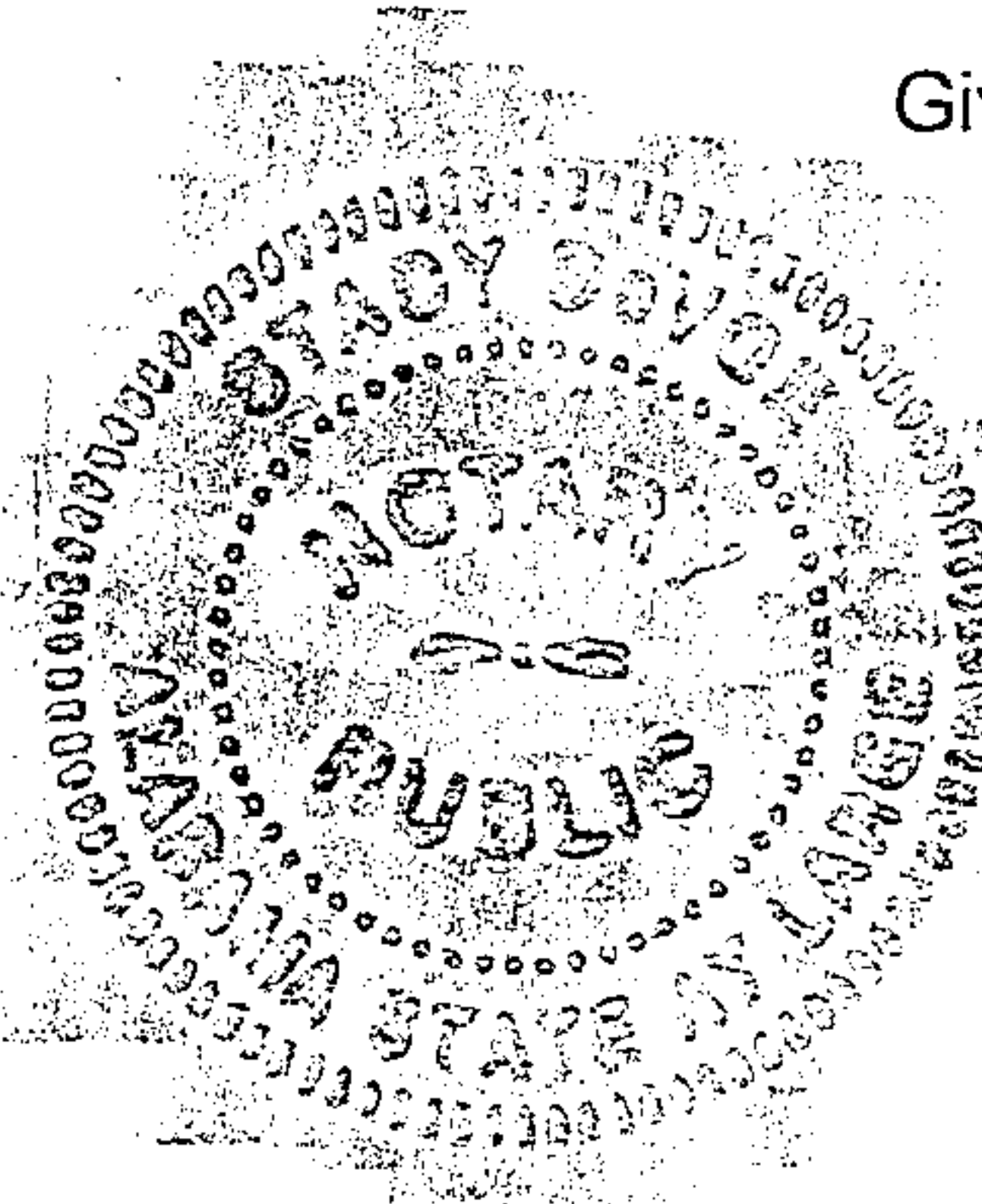
