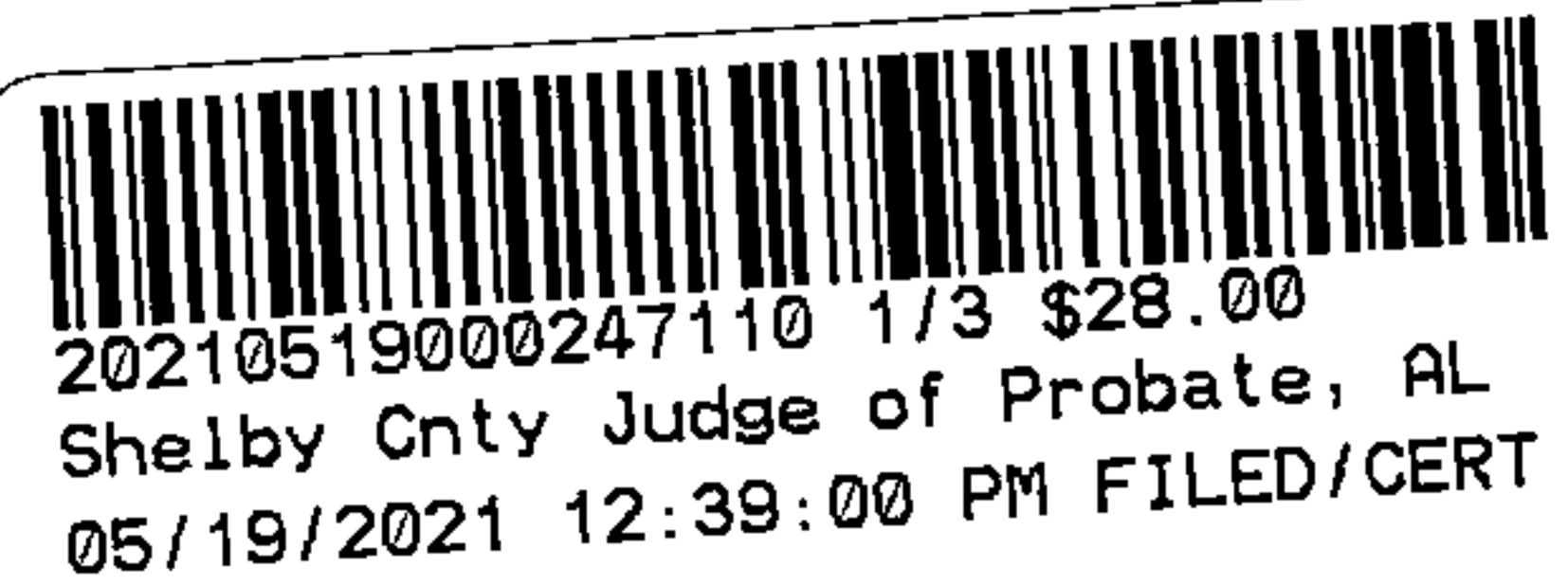

**ORDER ON MOTION TO AVOID JUDICIAL LIEN**  
**PURSUANT TO 11 U.S.C. §522(f)(1)(A)**
