
The herein described property does not constitute the homestead of the Grantors nor that of the their spouses.

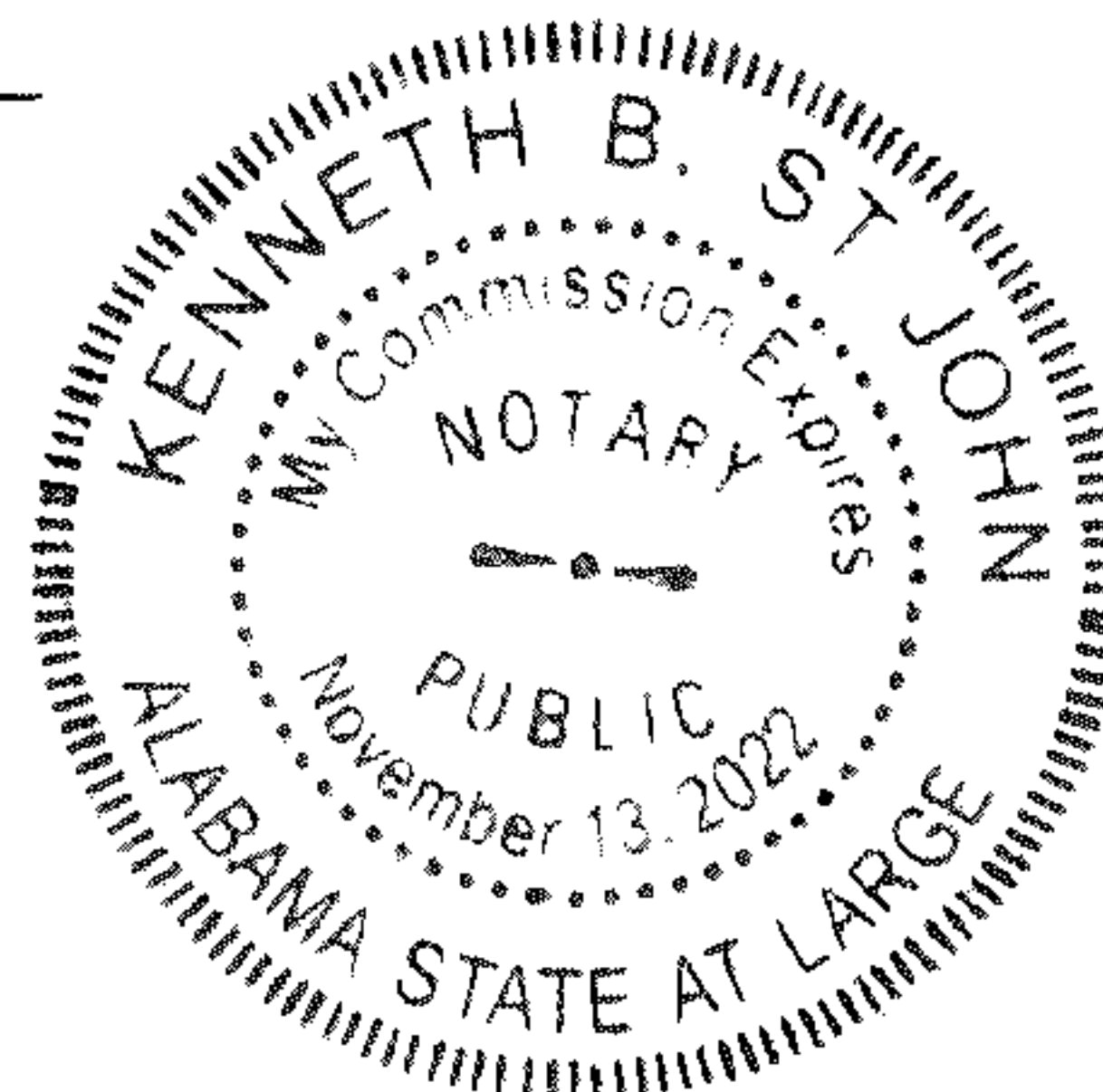
