The named guardian shall have any power regarding regarding to the consent of the following: Health, support, education or maintenance of the person or property of the minor.

It is my intention that the person named above shall have all of the powers of the heretofore stated, except the power to consent to marriage or adoption, of said child, for a period not exceeding one year from the date hereof. We further understand that this temporary power of attorney (delegation) of my parental powers does not relieve me of the primary responsibility of my child.

GIVING AND GRANTING unto said person full power and authority to do, take and perform all and every act and thing whatsoever requisite, proper or necessary to be done, in the exercise of any of the rights and powers herein granted , as fully to all intents and purposes for the benefit of my child, as I might or could do if personally present, hereby ratifying and confirming all that the said person shall lawfully do or cause to be done by virtue of this power of attorney (delegation of powers) and the rights and powers herein granted;

The above Power of Attorney (Delegation of Powers) of the above named person herein granted shall commence and be in full force and effect on the date set forth below; and such powers shall remain in full force and effect until ONE YEAR from the date set forth below;

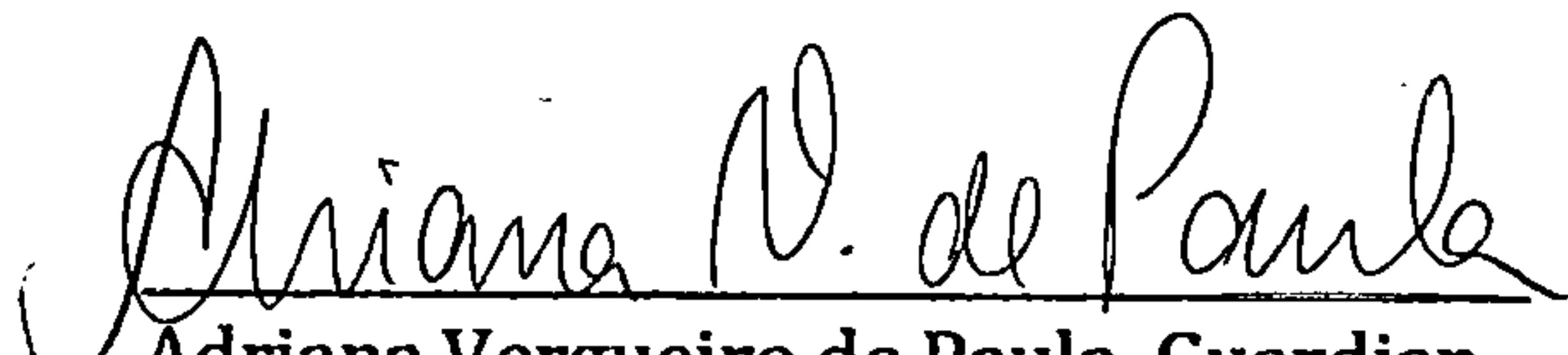

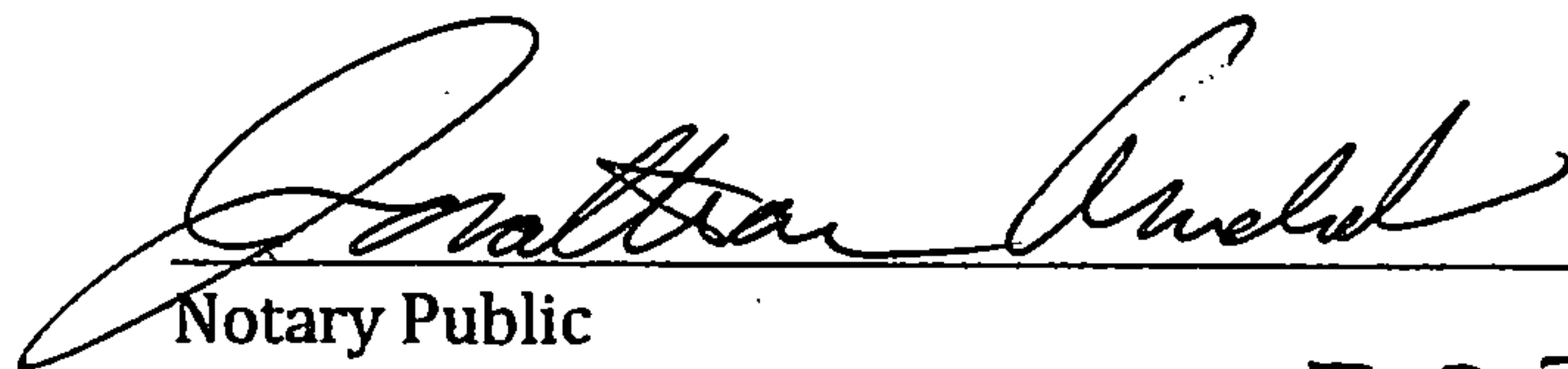
