WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this May 26, 2021, That for and in consideration of **TWO HUNDRED SIXTY EIGHT THOUSAND AND NO/100 (\$268,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **EDDIE B. ARRINGTON and ANGINETTE ARRINGTON, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **CAREY HILL and TERRELL D'MARCUS HILL**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 87, Hidden Forest, according to the plat thereof as recorded in Map Book 35, Page 117, Document No. 20050913000473700 in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2021 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 35, Page 117.
