That in consideration of **FOUR HUNDRED FORTY FIVE THOUSAND EIGHT HUNDRED EIGHTY SIX AND 00/100 DOLLARS** (\$445,886.00) to the undersigned grantor, **Lake Wilborn Partners, LLC, an Alabama Limited Liability Company**, (herein referred to as GRANTOR) in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **Jennifer Walz Lowe and Daniel Wayne Lowe**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:



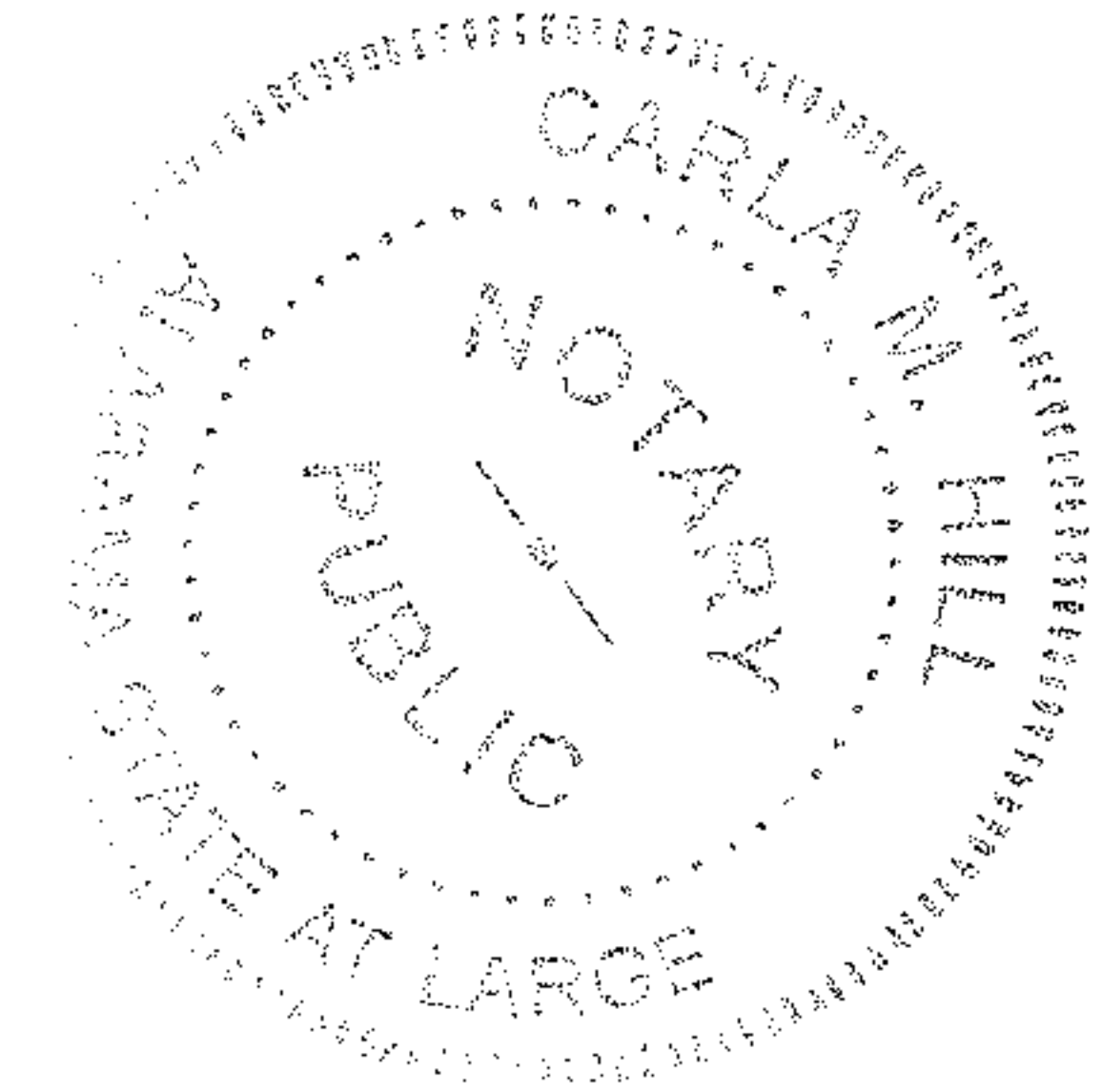
