WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Seven Hundred Forty-Five Thousand and 00/100 Dollars (\$745,000.00) the amount which can be verified in the Sales Contract between the two parties in hand paid to the undersigned, **CHRISTOPHER P PRESCOTT and NANCY M PRESCOTT**, HUSBAND AND WIFE, whose mailing address is: 100 Wickham Dr Tyne, Ga 30290 (hereinafter referred to as "Grantors") by **KEVIN PRICE and AMANDA PRICE** whose property address is: **276 HIGHLAND PARK DRIVE, BIRMINGHAM, AL, 35242** hereinafter referred to as Grantees"), the receipt and sufficiency of which are hereby acknowledged, Grantor does, by these presents, grant, bargain, sell, and convey unto Grantees, as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:
