Johnson and Latanya P. Johnson, Husband and Wife**, do hereby grant, bargain, sell and convey unto **Charles D. Saggus and Ashley Saggus**, as joint tenants with right of survivorship (herein referred to as Grantees), the following described real estate situated in Shelby County, Alabama, to-wit:


SUBJECT TO ALL MATTERS OF RECORD




