STATE OF ALABAMA SHELBY COUNTY LIFE ESTATE DEED

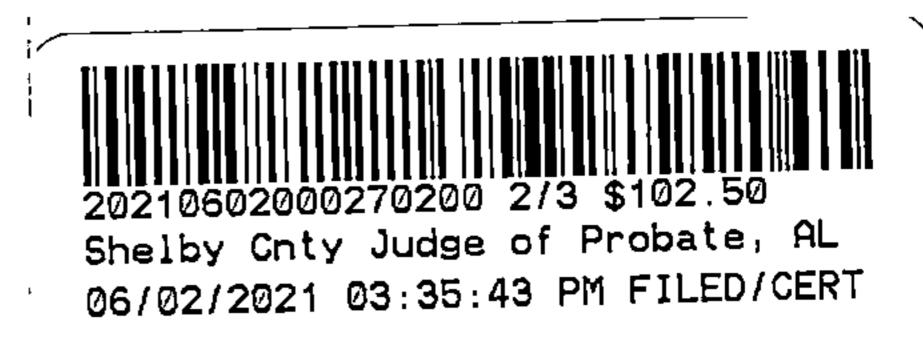
KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TEN (\$10.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, Angeline Harkness, an unmarried woman and the surviving grantee in the joint survivorship deed dated November 16, 2006 recorded in the Shelby County Probate Office as Instrument #20061120000565970, the other grantee, James S. Harkness Jr., having died on or about September 24, 2019 (nereinafter referred to as GRANTOR whether one or more), the receipt whereof is hereby acknowledged, it is the intention of the GRANTOR to reserve to herself during the full term of her natural life the right of possession and occupancy in and to the real estate and the rents and profits arising from it, and to convey unto the GRANTEE, Gaythan Renee VonMallinckrodt, a married woman (hereinafter referred to as GRANTEE whether one or more), the full fee simple title to the real estate, subject only to a life estate reserved here by GRANTOR, legally described as;

Lot 79, according to the Survey of Daventry Sector II, as recorded in Map Book 29, Page 32, in the Probate Office of Shelby County, Alabama.
