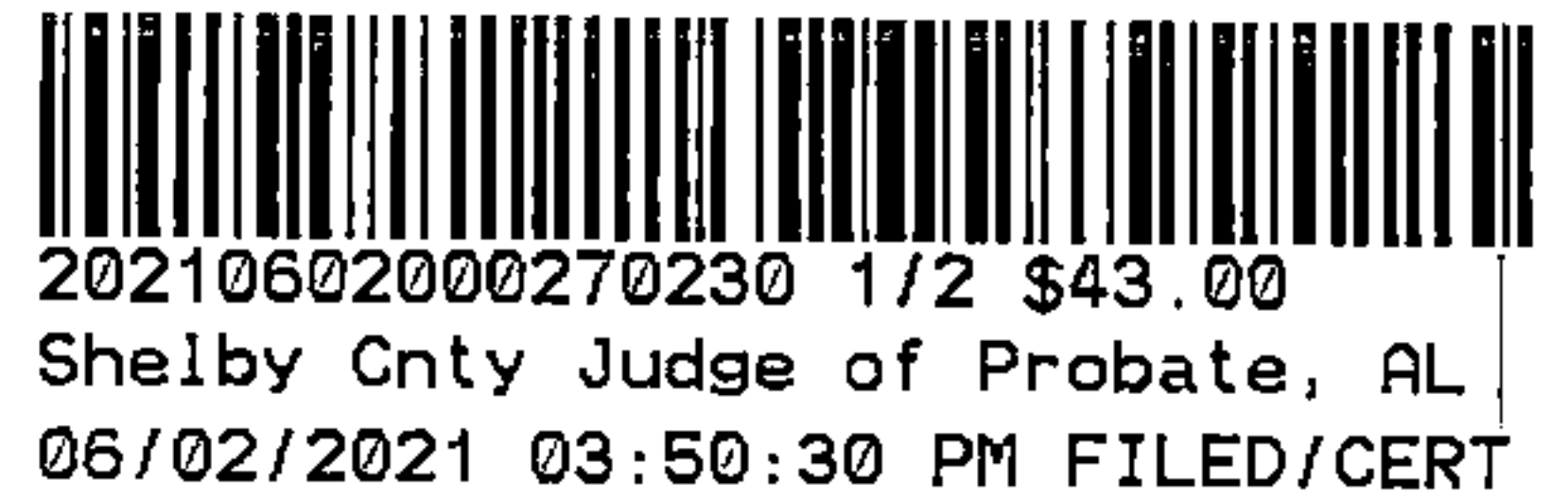

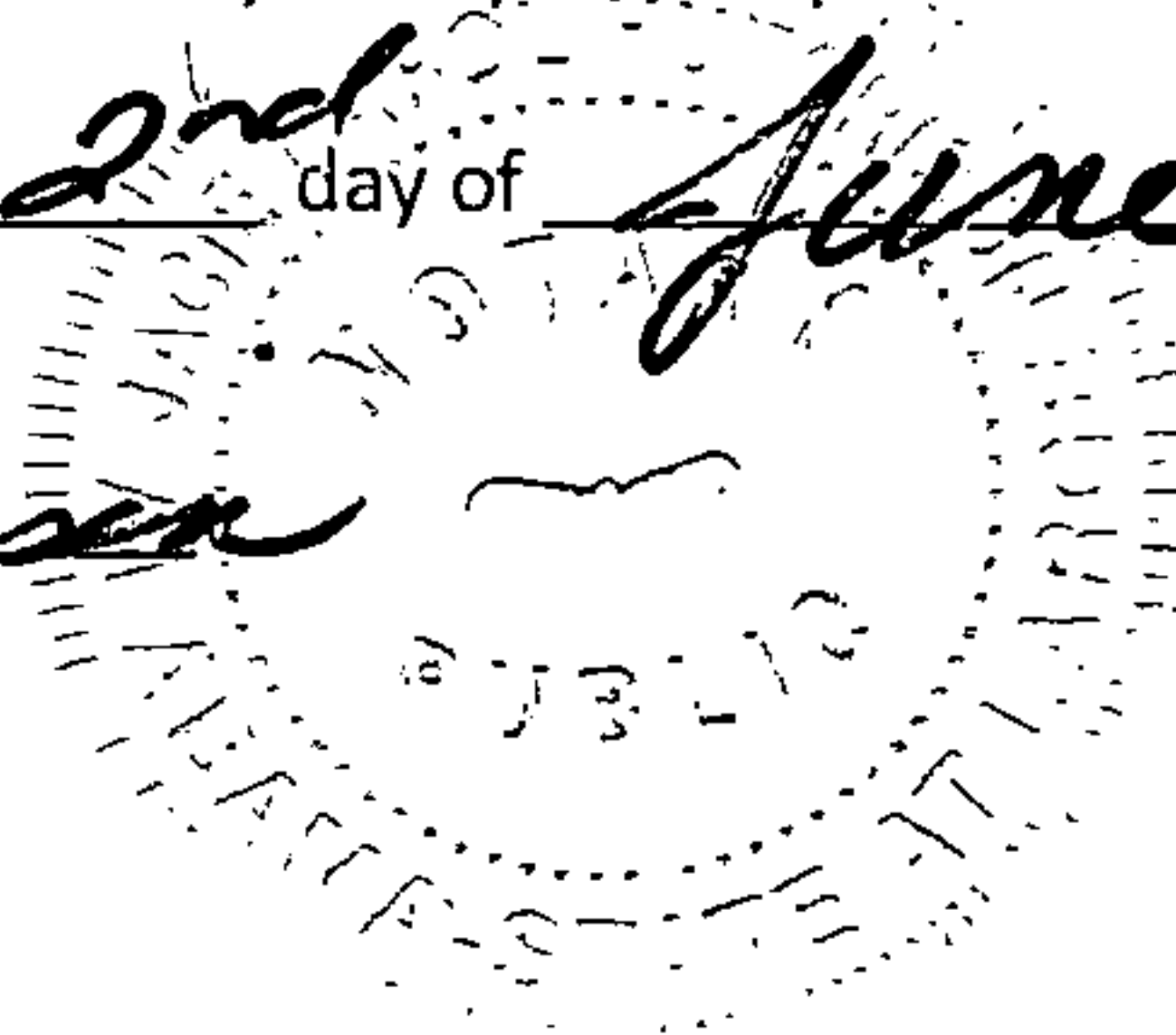
## OATH OF OFFICE
