Heather Ferguson, Formerly Known As Heather L. Rylee, a married woman and Stephen D. Rylee, a single man, whose mailing address is:

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

Maci R. Gardner and Kaitlyn Harvel, whose mailing address is:

(herein referred to as grantees) as joint tenants with right of survivorship, the following described real estate property situated in Shelby County, Alabama, the address of which is: 273 Nottingham Dr., Calera, AL 35040 to-wit:

Lot 112, according to the Final Plat of Nottingham, Phase 2, as recorded in Map Book 31, Page 62, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Rylee and Heather Ferguson are the surviving Grantees of that certain Deed dated April 20, 2005 and recorded April 21, 2005 in Instrument No. 2005042000189040, in the Probate Records of Shelby County, Alabama, the other Grantee, Sandra M. The herein conveyed property does not constitute the homestead of Heather Ferguson, nor that of her spouse, neither is it contiguous hereto.

And I (we) do for myself (ourselves) and for my (our) heirs, executors and administrators covenant with the said Grantees, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrants and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.

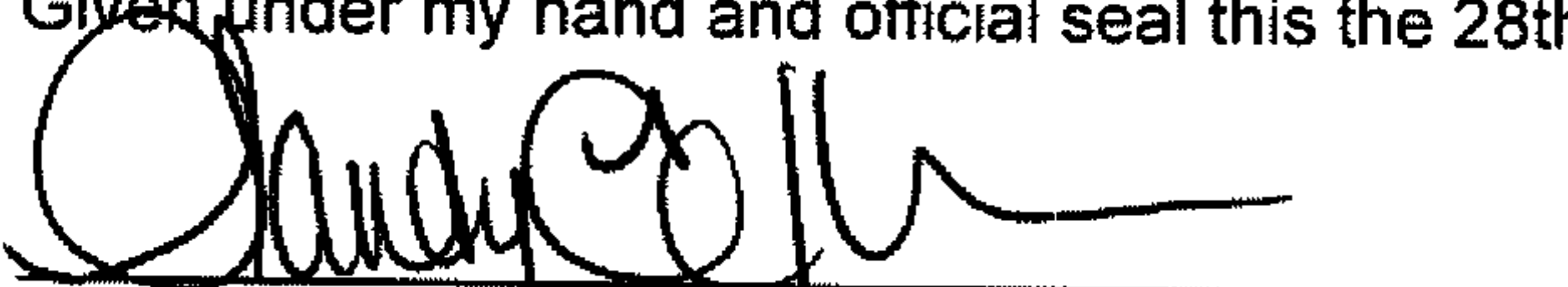

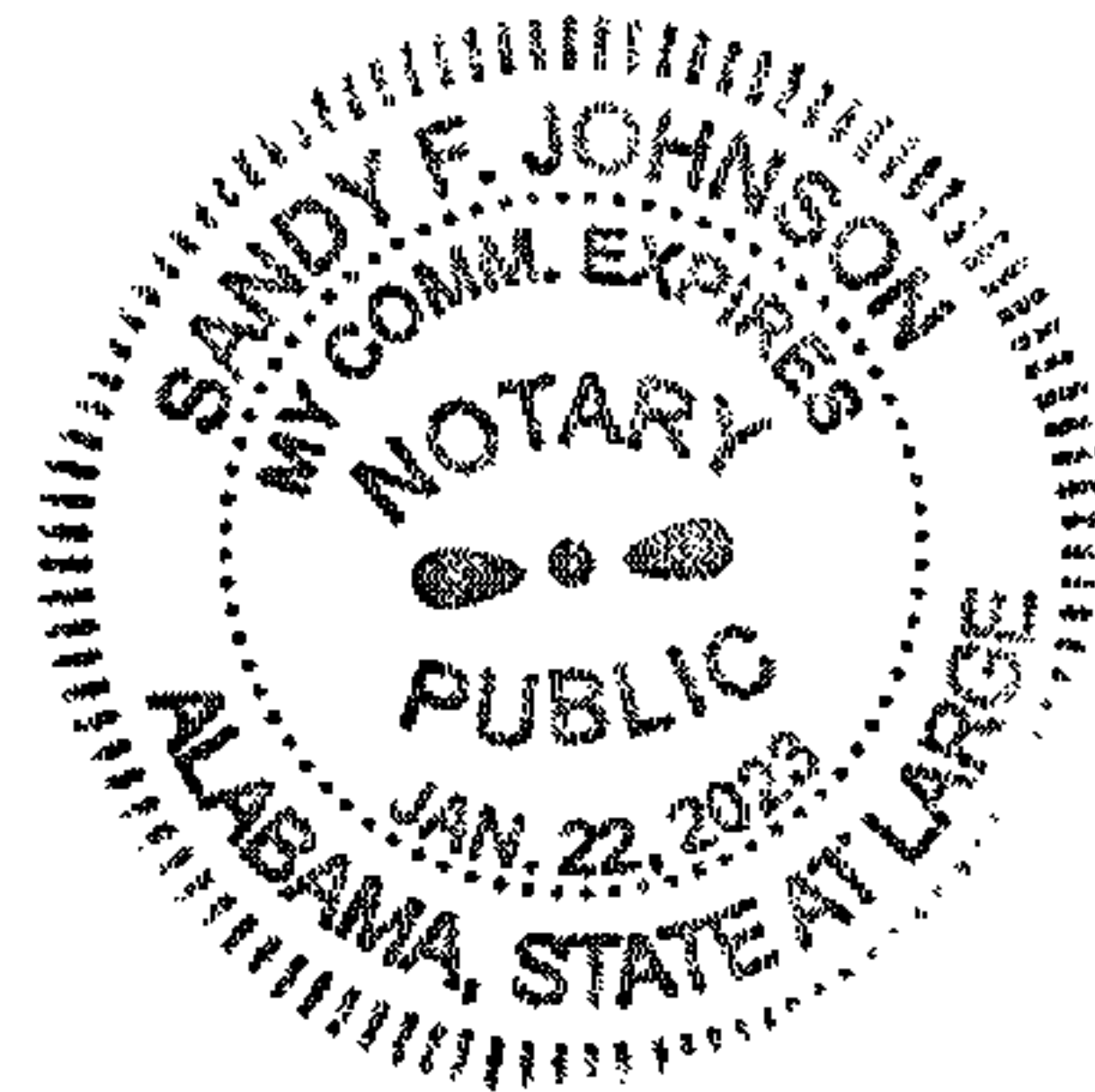
