FINAL JUDGMENT

This matter comes before the Court on the joint motion of the Plaintiff and the Defendants to enter final judgment (Adv doc. 129) pursuant to a Settlement Agreement approved by this Court by order entered in the above-styled main case, No. 16-00138-TOM-13 dated April 19, 2021 (doc. 123). The Settlement Agreement approved by the Court provides that all parties to this adversary proceeding, Plaintiff Sensible Loans, Inc., Defendant Raymond Louis Smith, III, and Defendant Elizabeth Kelly Bowlin, will jointly request that this Court enter final judgment by consent which contains certain agreed-upon provisions. The said parties have each requested immediate entry of final judgment by consent without further hearing and they have each waived notice and a hearing. Therefore, upon the joint motion of the parties and in accordance with the Settlement Agreement approved by the Court, the Court finds, concludes, determines, orders, and enters final judgment as follows:

- 1. Final Judgment is hereby entered in favor of Plaintiff Sensible Loans, Inc. and against Defendants Raymond Louis Smith, III and Elizabeth Kelly Bowlin, jointly and separately, for \$620,000.00. This judgment shall bear interest at the rate of 21% per annum.
- 2. Each of the judgments entered herein against Defendants Raymond Louis Smith, III and Elizabeth Kelly Bowlin, jointly and separately, is excepted from discharge under Bankruptcy Code §§523(a)(2), (4), and (6).
- 3. Defendant Raymond Louis Smith, III holds legal title to the following described real property located in Walton County, Florida, hereinafter referred to as "the Florida Property":

Lot 5, in Windancer Condominiums and Windancer Shores, a subdivision located in Section 33, Township 2 South, Range 21 West, according to the plat thereof, as recorded in Plat Book 12, Page 29 and 29A, of the public records of Walton County, Florida.

- 4. Defendant Elizabeth Kelly Bowlin holds no right, title, or interest in and to the Florida Property.
- 5. Plaintiff Sensible Loans, Inc. holds an equitable lien on the Florida Property to secure the judgment entered in Paragraph 1 above. The equitable lien is effective and enforceable as of April 8, 2016. The equitable lien is superior to and higher in priority and seniority than all other liens and encumbrances on the Florida Property except for ad valorem taxes.
- 6. Sensible may record this judgment, or a certificate thereof, in any probate office or similar office where real property records and judgments may be recorded. Additionally, Plaintiff Sensible Loans, Inc. shall cause this judgment, or a certificate thereof, to be recorded in the Official Records of Walton County, Florida as evidence of its lien against the Florida Property to secure the judgment.
