- 1. I am over the age of 21 years and have personal knowledge of the following facts.
- I prepared that certain Statutory Warranty Deed dated June 5, 2001 and filed for record in the office of the Judge of Probate of Shelby County, Alabama on June 20, 2001 which is there recorded as **Instrument No. 2001-25405**.
- 3. Due to a scrivener's error omitting the Township and Range, the legal description in the above described Instrument reads as follows:
