THAT IN CONSIDERATION OF **Three Hundred Twenty Thousand Dollars and NO/100 (\$320,000.00)** to the undersigned grantor, in hand paid by the grantees herein, the receipt whereof is acknowledged, I, **Laura Mia Markris, a single person**, (herein referred to as grantor), grant, sell, bargain and convey unto, **Thomas H. Wester, Jr. and Tamara O. Wester** (herein referred to as grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

**Lot 50, according to the Survey of Oak Glen, First Sector, as recorded in Map Book 9, Page 104, in the Probate Office of Shelby County, Alabama.**

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.


