**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

On this June 3, 2021, That for and in consideration of **ONE HUNDRED FOURTEEN THOUSAND NINE HUNDRED AND NO/100 (\$114,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **GARY WILLIAM JUSTISS and JENNIFER LEWIS JUSTISS, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **CHRISTOPHER FORMENTANO and HANNAKATE FORMENTANO**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 1, according to the Survey of Skelton Family Subdivision, as recorded in Map Book 41, Page 13, in the Probate Office of Shelby County, Alabama.

Subject to:

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 41, Page 13.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


