years in the State of Alabama.

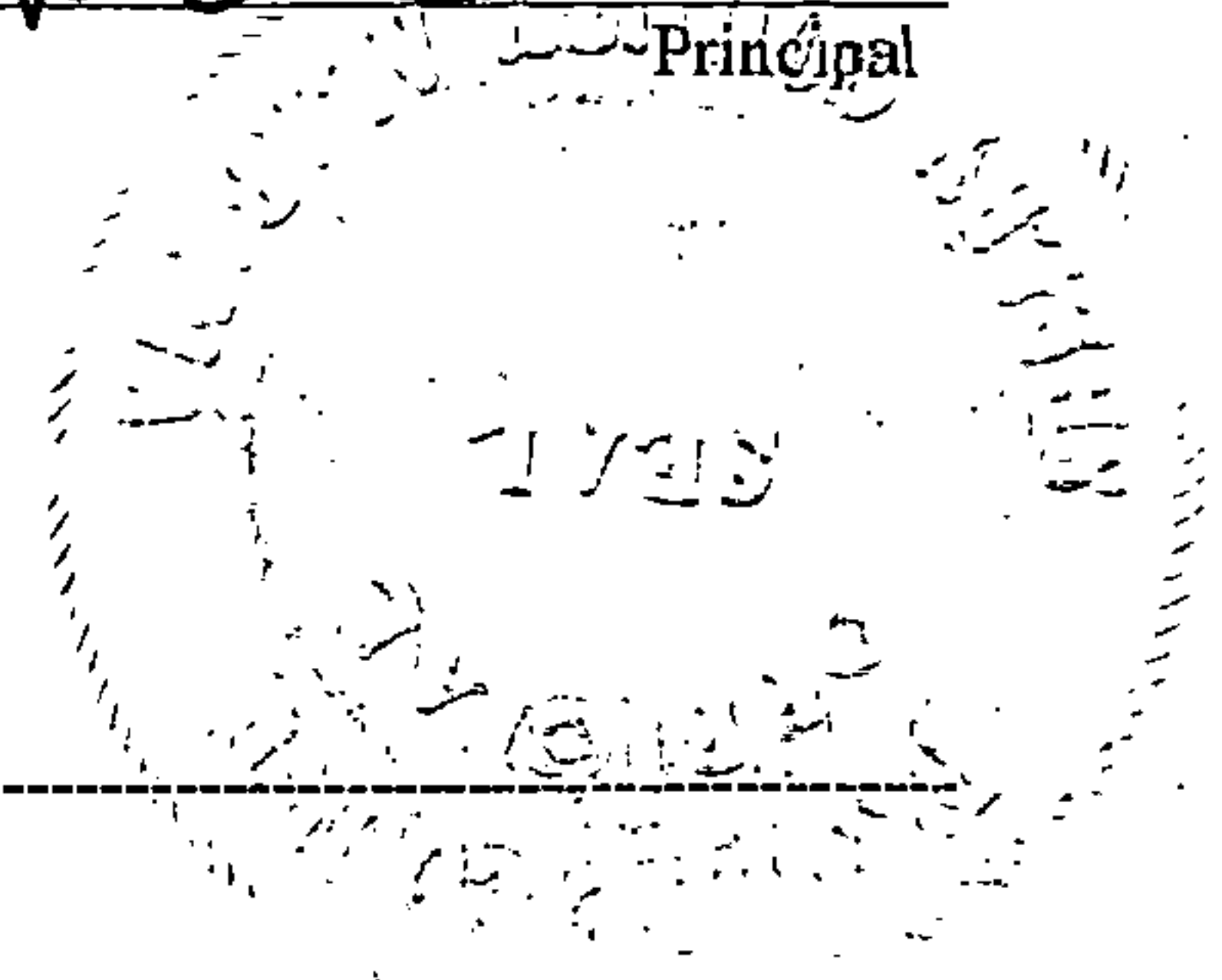

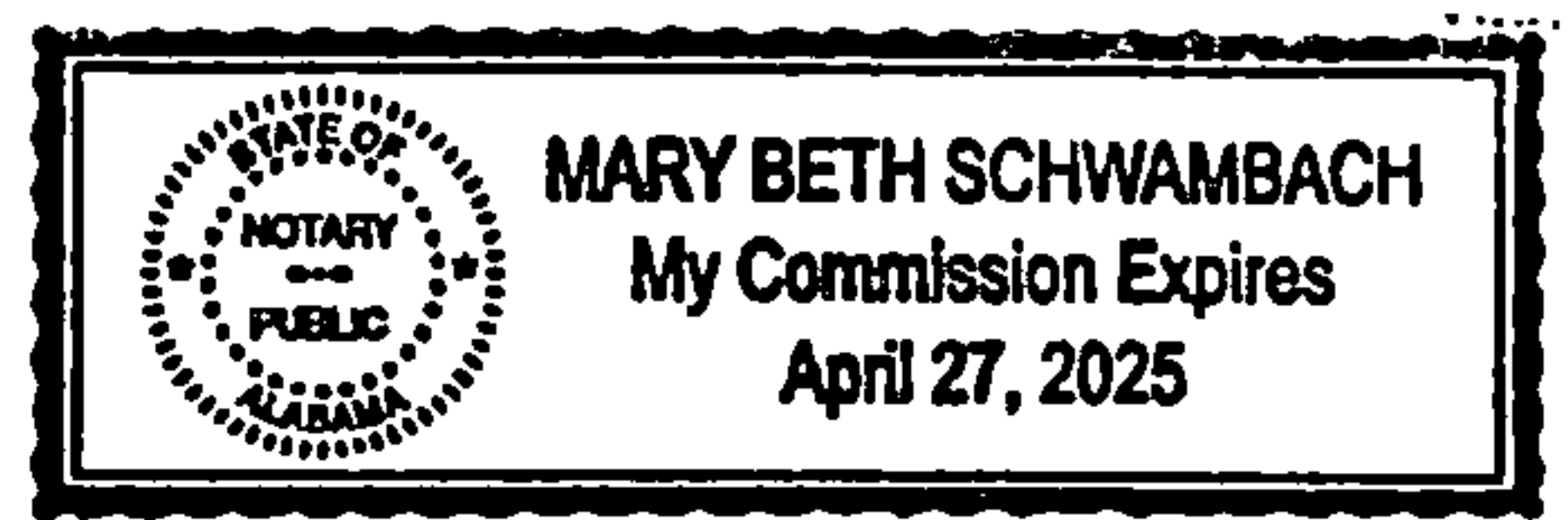
