Know All Men by These Presents: That in consideration of **Three Hundred Twenty Thousand and 00/100 Dollars (\$320,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **ERNEST GUERRA and HOPE GUERRA, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **STEVEANNA MARIE WILLIAMS and RYAN RICHARD WILLIAMS** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:




