**STATUTORY WARRANTY DEED (Joint Tenants With Rights of Survivorship)**

KNOW ALL MEN BY THESE PRESENTS:

Ninety-Nine and No/100 (\$ 237,299.00 ) Dollars  
(as evidenced by the closing statement)  
and other good and valuable consideration to the undersigned
