On this June 18, 2021, That for and in consideration of **THREE HUNDRED FIFTY FIVE THOUSAND AND N0/100 (\$355,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **GEORGE MANSOR ANNAB and JENNIFER ANNAB, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **PHILIP SIMON and SUSAN SIMON**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 1618, according to the Final Plat of Strathaven at Ballantrae Phase 1, as recorded in Map Book 37, Page 128, in the Probate Office of Shelby County, Alabama.

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 37, Page 128.



The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


