

ORDER

THIS CAUSE was called for trial on August 2, 2017 and the Defendant having failed to appear after due notice, and the Plaintiff appearing with her attorney of record, the court heard ore tenus testimony from the Plaintiff and the Court hereby enters the following order in this matter.

FINDINGS OF FACTS

- 1. That on or about June 10, 2017, the Plaintiff went to the Defendant's residence to retrieve personal property from Defendant's possession.
- 2. That after knocking at the door of the Defendant and asking for the return of her personal property, Plaintiff was verbally and physically attacked by the Defendant. Plaintiff testified that Defendant cursed at her, lunged at her and grabbed her in an attempt to push her off of a deck. Plaintiff testified that she was then pinned by the Defendant against the deck's railing where she was physically attacked by the Plaintiff. Plaintiff was then knocked down onto the deck where the Defendant continued his physical assault against the Plaintiff by beating her with his fists, strangling her with his forearm and beating the Plaintiff 's head against the decking.



- 3. That said attack caused serious physical, mental and emotional injury to the Plaintiff.
- 4. That as a result of such assault, the Plaintiff suffered injuries and damages including, but without limitation, extreme embarrassment and emotional trauma; extreme emotional distress and mental anguish; bruises contusions and head trauma; multiple fractures in her left wrist and arm; permanent injury and damages; expenses for treatment from doctors, physicians, counselors, therapists and hospitals; loss of ability to work; and continuing expenses for the future treatment from various doctors, physicians, counselors, therapists and/or medical providers.
- 5. That on or about June 10, 2014, the Defendant converted assets belonging to the Plaintiff to his own use and gain, to-wit: one Apple laptop computer valued at Five Thousand and no/100 Dollars (\$5,000.00).
 - 6. All other claims for relief are denied.
 - 7. Court costs are hereby taxed as paid.

ACCORDINGLY, this Court finds that each count contained in Plaintiff's Complaint and Amended Complaint are true and it is therefore, ORDERED, ADJUDGED and DECREED that a judgment is hereby entered in favor of the Plaintiff, Stephanie Samudio, against the Defendant, JEFFERY WADE BEATY, as follows:

A. Plaintiff is awarded compensatory damages in the amount of

- B. Plaintiff is awarded punitive damages in the amount of \$ 10,000.
- C. Plaintiff is awarded a judgment against the Defendant in the amount of Five Thousand and no/100 Dollars (\$5,000.00) as a result of the Defendant's conversion of Plaintiff's personal property.
