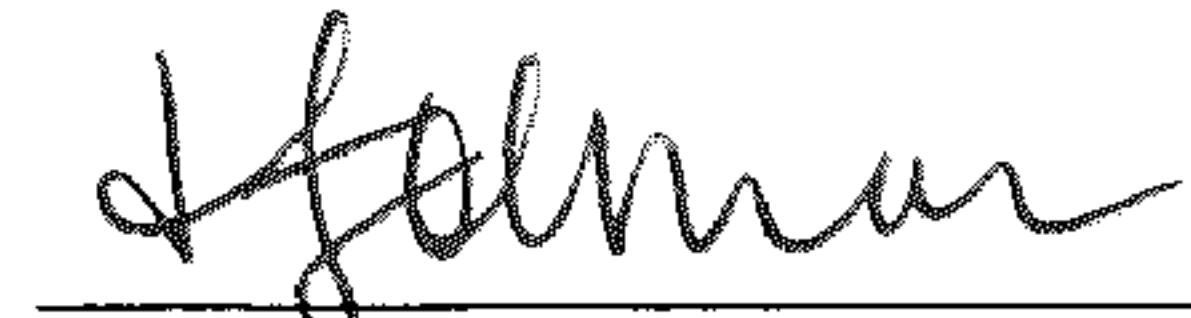
Be it known that \$163,000.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.

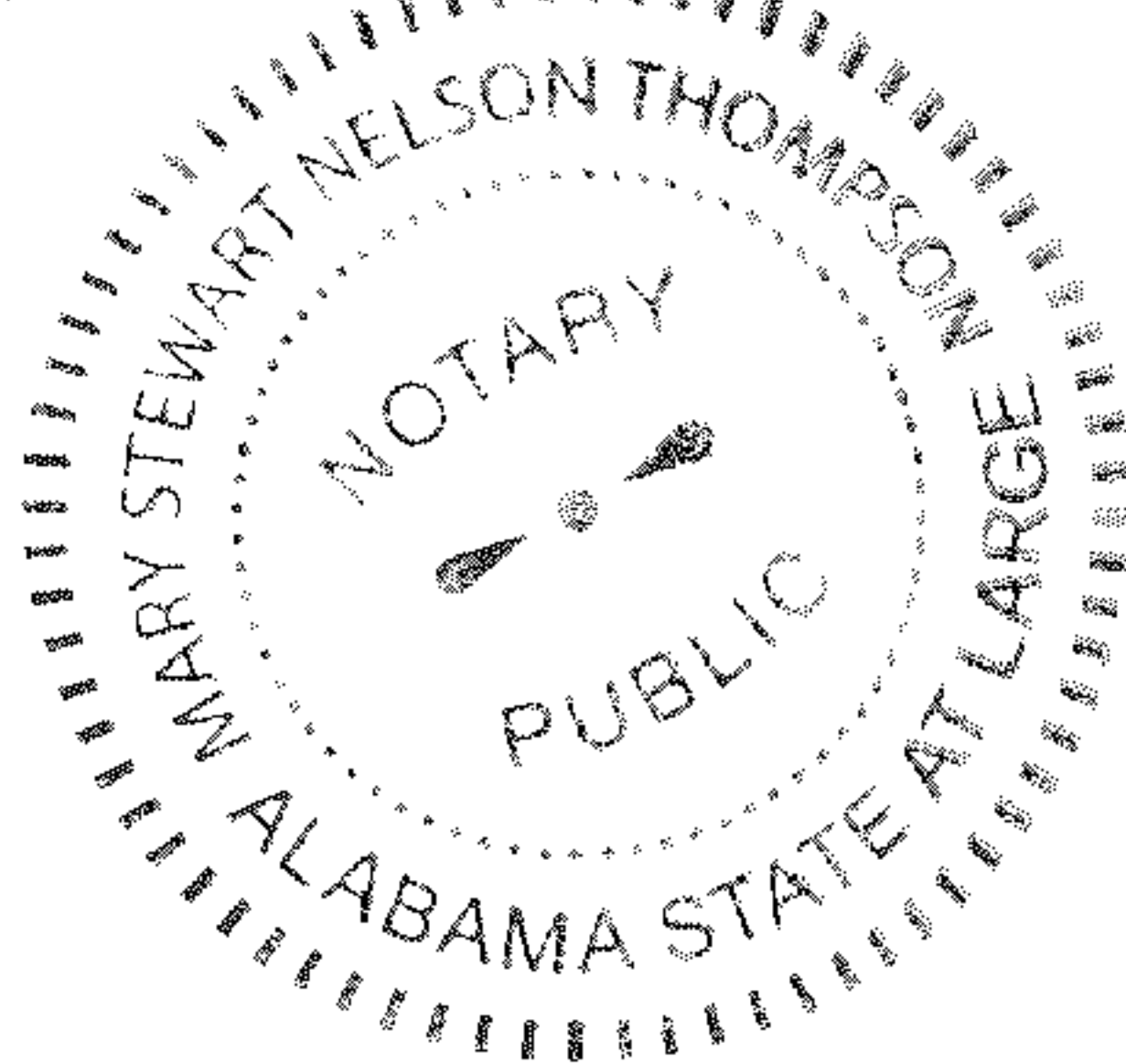

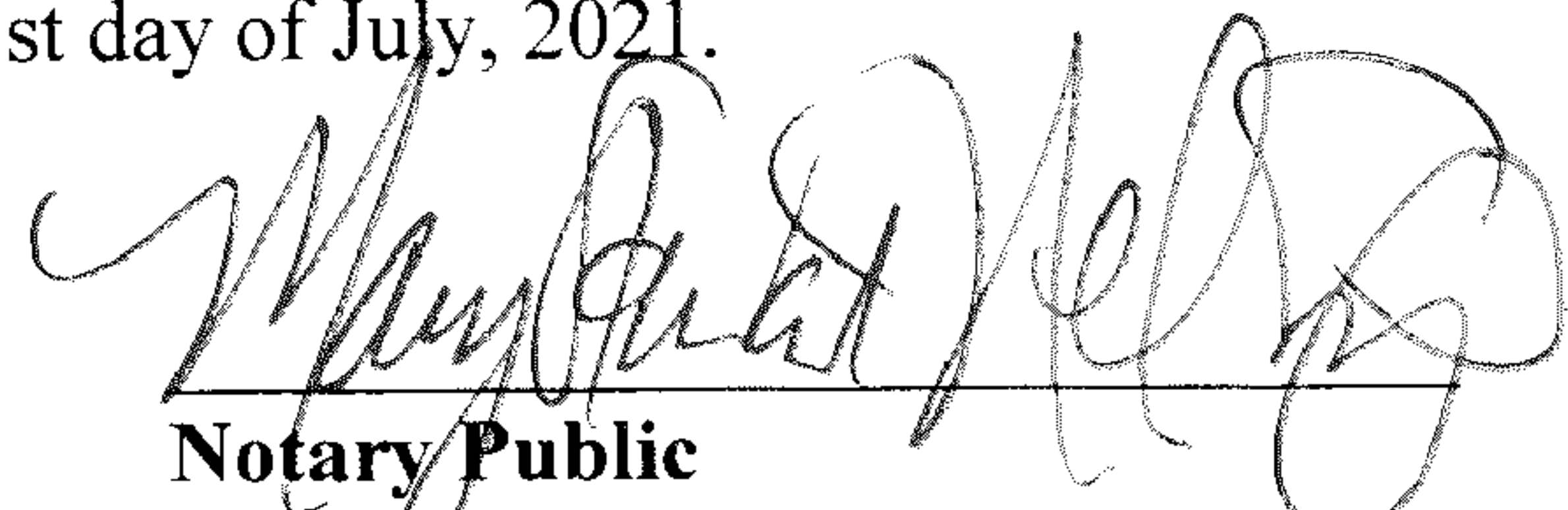
