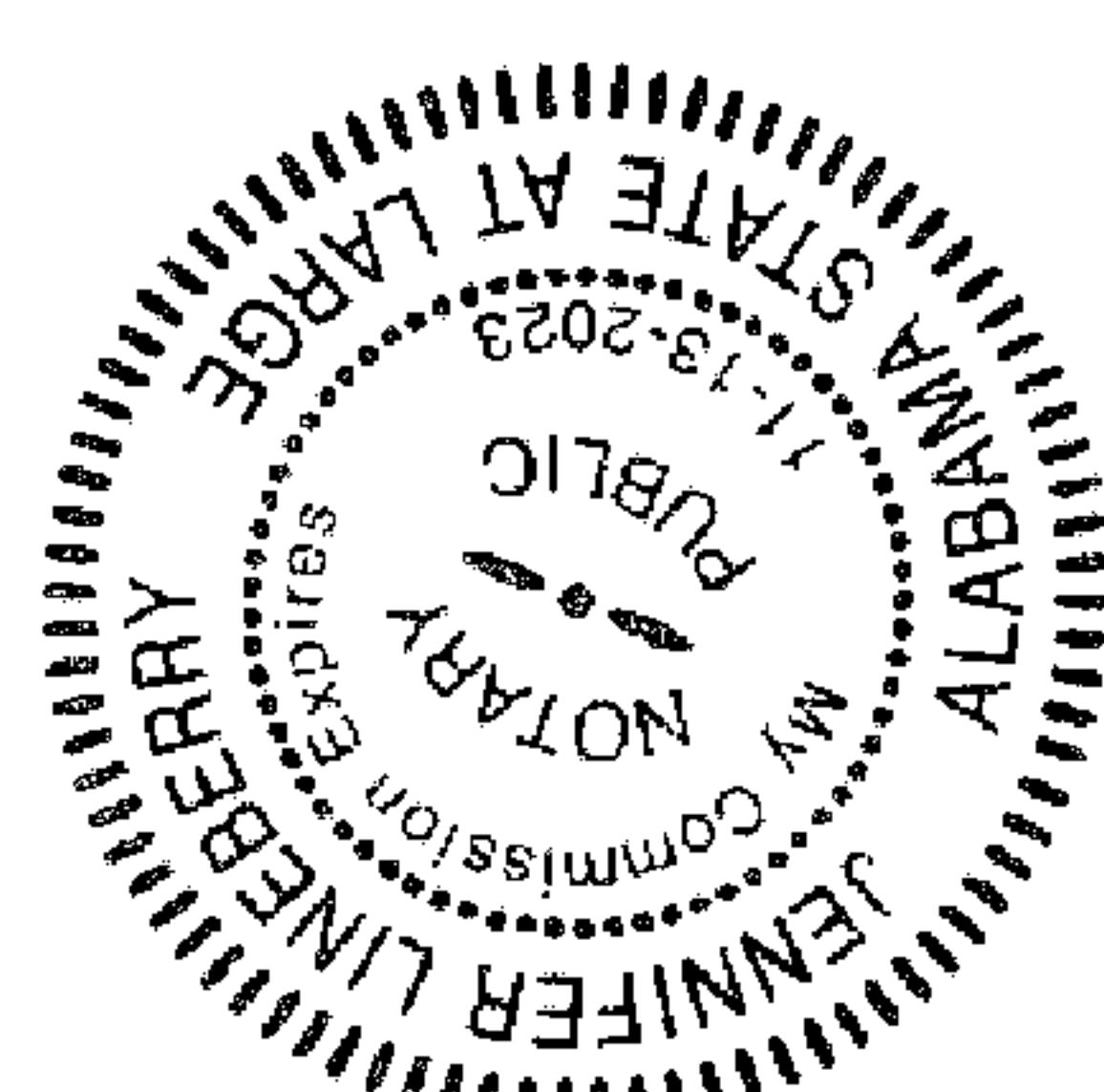

The film is patterned with a periodic array of rectangular holes. The film is irradiated with 100 eV electrons at an angle of 45° to the surface. The electron beam is focused to a spot of diameter $1 \mu\text{m}$. The electron energy loss signal (EELS) is collected at an angle of 90° to the incident electron beam. The EELS signal is collected at a rate of 100 Hz .
