RANDY GOODWIN is one and the same person as JAMES RANDALL GOODWIN.

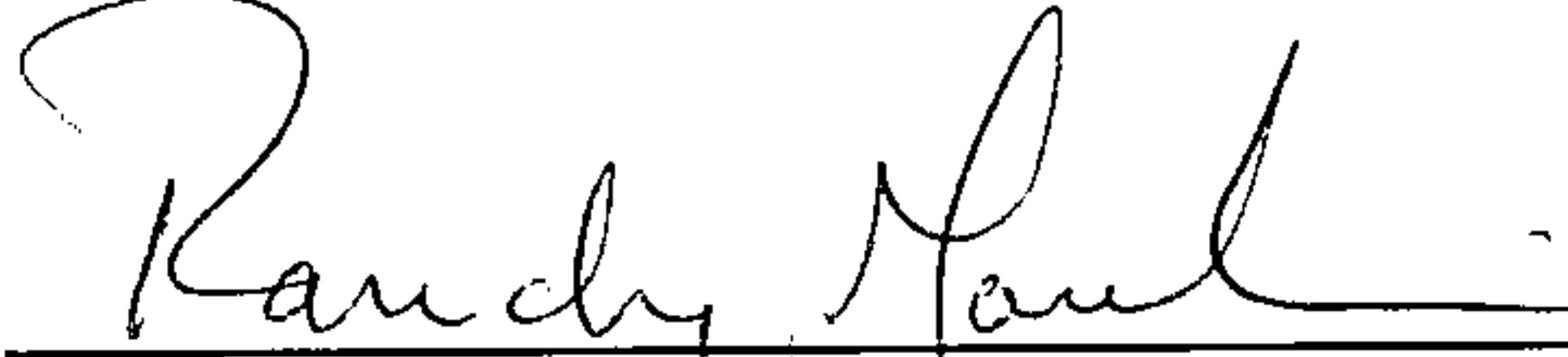
Subject to mineral and mining rights if not owned by Grantor. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.
