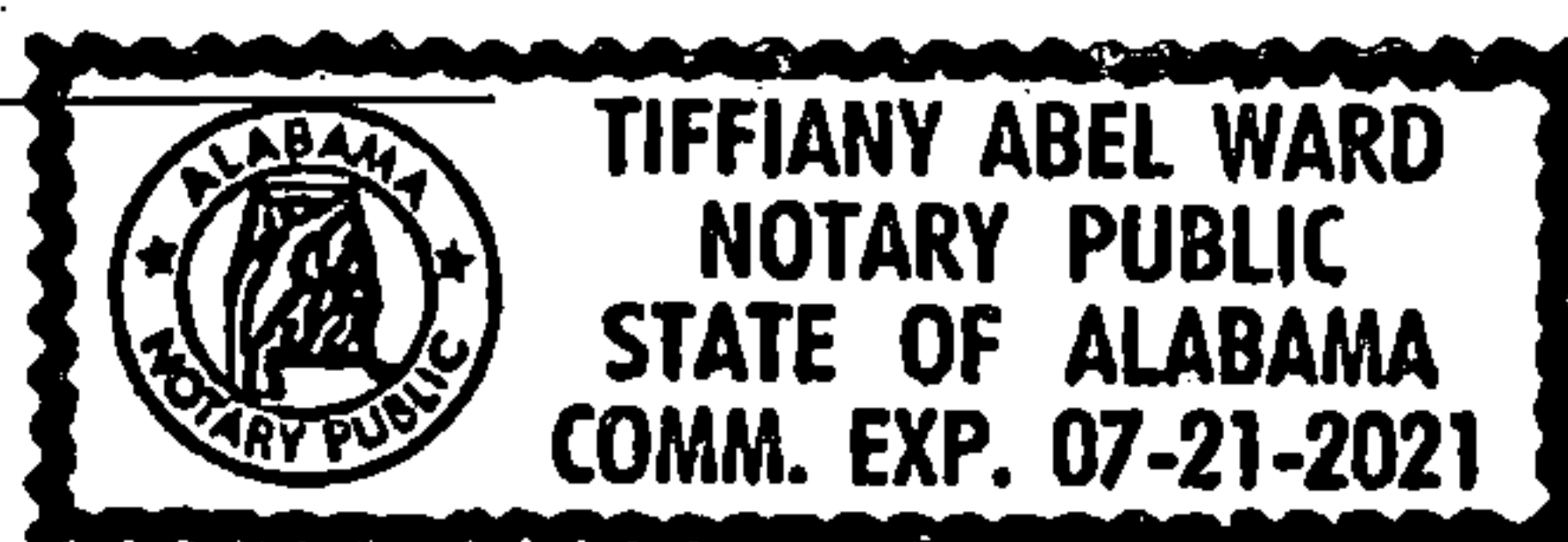
**OATH OF OFFICE**
