LIMITED DURABLE POWER OF ATTORNEY

This power of attorney shall remain in effect through August of 2021.

This Durable Power of Attorney is executed pursuant to Alabama Uniform Power of Attorney Act, Chapter 1A, Title 26, Code of Alabama 1975. This power of attorney shall not be affected by the disability, incompetency, or incapacity of the principal.

To exercise or perform any act, power, duty, right, or obligation whatsoever that I now have or may hereafter acquire, relating to the selling of my home, including, without limitation, the following specifically enumerated powers. I grant to my Agent full power and authority to do everything necessary in exercising any of the powers herein granted as fully as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my Agent shall lawfully do or cause to be done by virtue of this power of attorney and the powers herein granted;

POWER TO SELL

To sell, mortgage, pledge, lease, and convey real property on such terms and conditions as my Agent shall deem proper, with full authority to sign, endorse, execute and deliver any sales agreement, deed, and all other instruments or documents pertaining to the sale of my home and to enter into bonds, contracts, mortgages and deeds connected therewith;

MANAGEMENT POWERS

To maintain, repair, improve, invest, manage, and in any manner deal with the sale of my home, that I now own, upon such terms and conditions as my agent shall deem proper;

BANKING POWERS

To make, receive and endorse checks, deposit funds, execute or release security agreements as may be necessary or proper in the exercise of the rights and powers herein granted;

INTERPRETATION AND GOVERNING LAW

This instrument is to be construed and interpreted as a limited durable power of attorney for the specific purpose of selling a home. This instrument is executed and delivered in the State of Alabama, and the laws of the State of Alabama shall govern all questions as to the validity of this power and the construction of its provisions.

THIRD PARTY RELIANCE

Third parties may rely upon the representations of my Agent as to all matters relating to any power granted to my Agent, and no person who may act in reliance upon the presentations of my Agent or the authority granted to my Agent shall incur any liability to me or my estate as a result of permitting my Agent to exercise any power.

REVOCATION

This Limited Durable Power of Attorney may be voluntarily revoked by me by written instrument delivered to my Agent. Any affidavit executed by my Agent stating that he or she does not have, at the time of doing any act pursuant to this power of attorney, actual knowledge of the revocation or termination of this power of attorney, is, in the absence of fraud, conclusive proof of the non-revocation or non-termination of the power at that time.

DEATH

My death shall not revoke or terminate this agency as to my Agent or any other person who, without actual knowledge of my death, acts in good faith under this power of attorney. Any action so taken, unless otherwise invalid or unenforceable, shall be binding upon me and my heirs, devisees, and personal representatives.
