A certain tract of land in the Town of Calera, Alabama, more particularly described as follows:

Beginning 100 feet South of the Northeast corner of Block 45, Dunstan's survey of Calera, Alabama; thence South parallel with the Montgomery-Birmingham Highway 50 feet; thence West 150 feet perpendicular to said highway; thence North 50 feet parallel with the said highway; thence East 150 feet perpendicular to the said highway to the point of beginning. This Power of Attorney shall remain in effect until revoked by me in writing and said revocation is recorded in the Office of the Probate Judge of SHELBY County, Alabama. This document hereby expressly revokes any previous Power of Attorney executed by me, regardless of requirements or revocation contained therein.


