This document hereby expressly revokes any previous Power of Attorney executed by me, regardless of requirements or revocation contained therein.

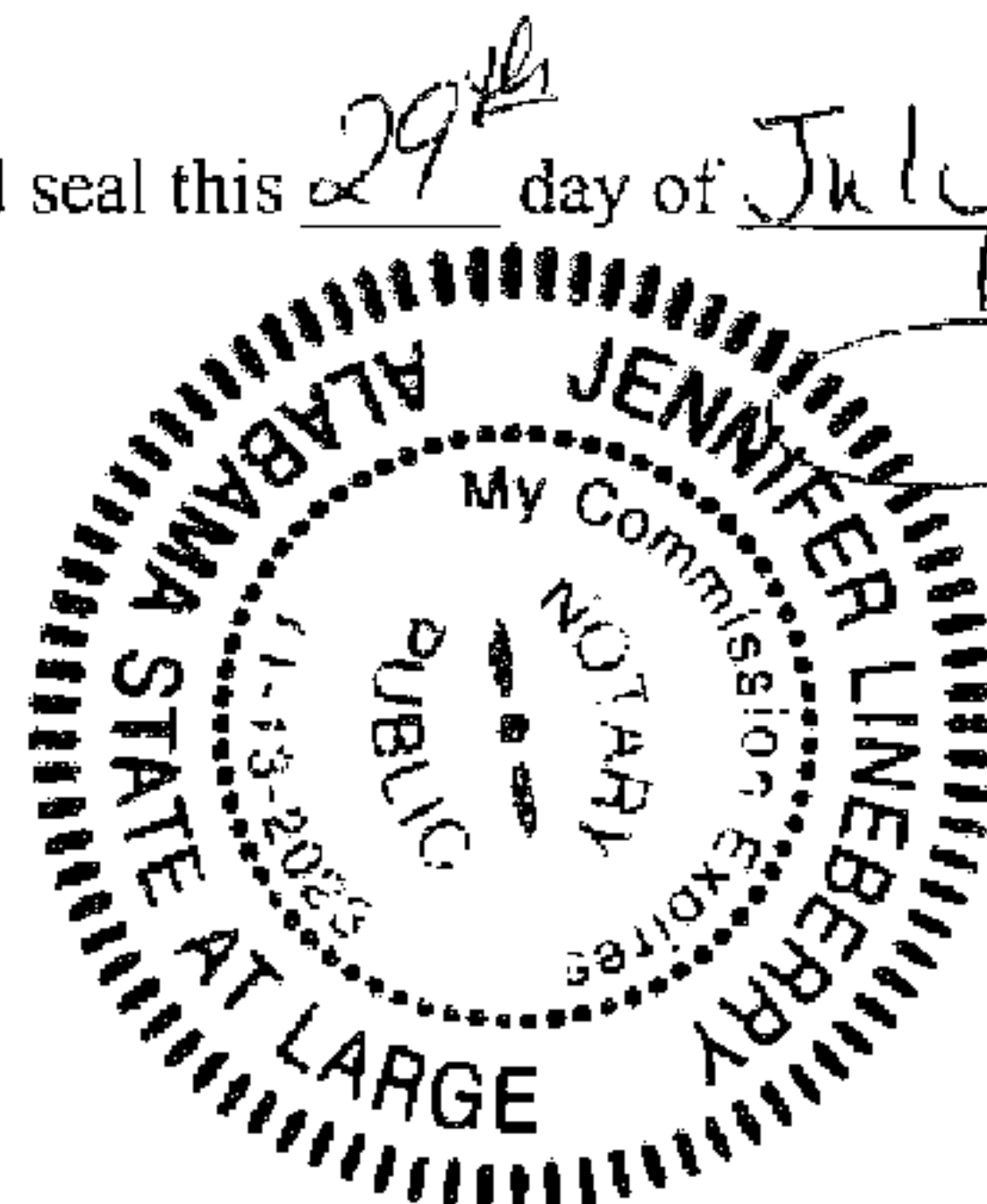


