Building lines, right of ways, easements, restrictions, reservations and conditions, if any, as recorded in Plat/Map Book 7, Page 150.



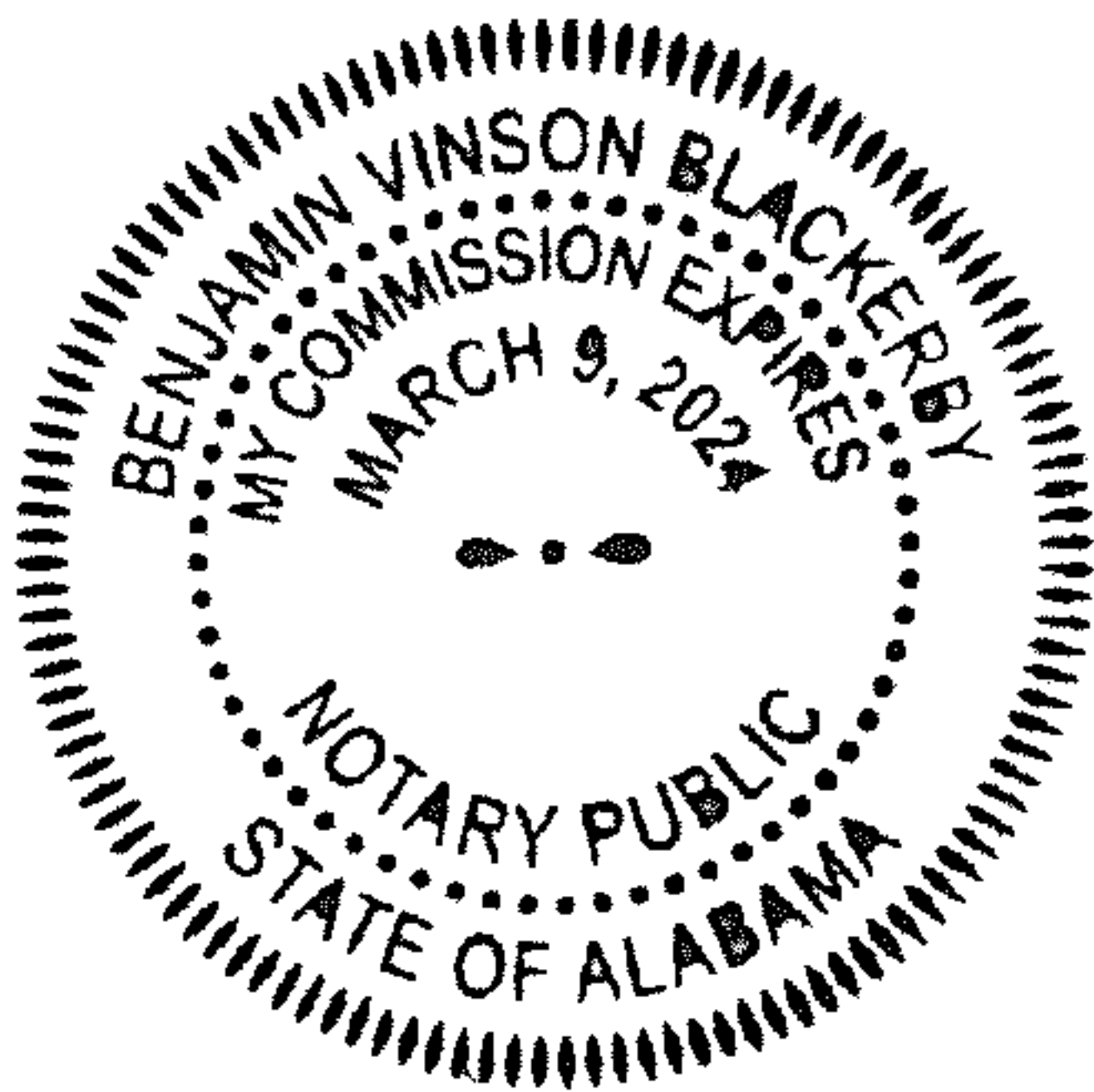


