Lot 4125, according to the Survey of Abingdon by the River as recorded in Map Book 52, page 66, in the Probate Office of Shelby County, Alabama.


SUBJECT TO ALL MATTERS OF RECORD



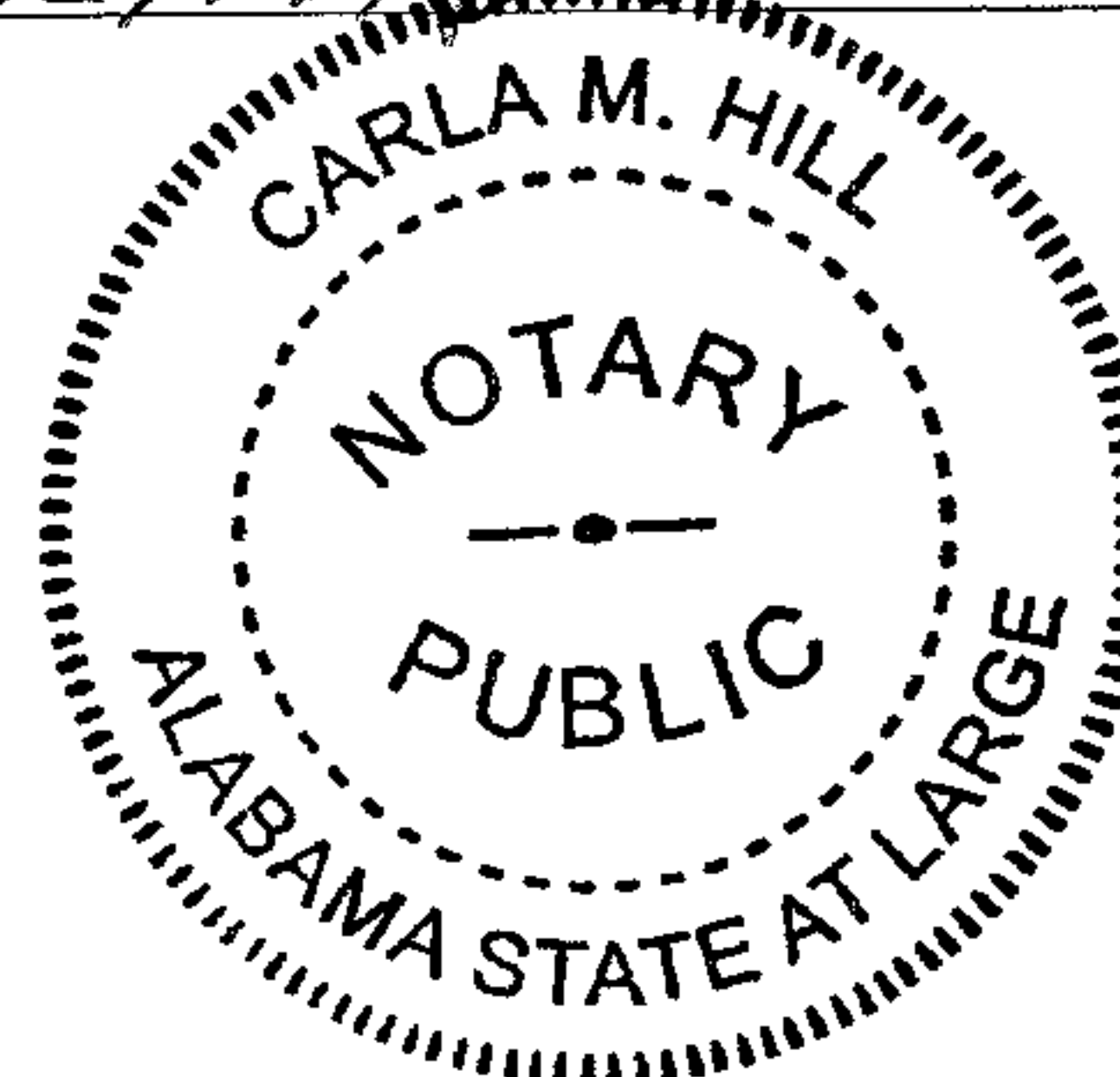
