FINAL JUDGMENT OF DIVORCE

This cause, coming on to be heard, was submitted for final judgment upon the pleadings and proof. Upon consideration thereof, it is ordered and adjudged by the Court as follows:

FIRST: That the bonds of matrimony heretofore existing between the parties are dissolved, and the said Anne Marie Held and said James Stewart Robinson are divorced each from the other.

SECOND: That neither party shall marry again except to each other until sixty (60) days after the date of this Judgment of Divorce, and if an appeal is taken (which must be instituted within forty-two [42] days from this Judgment, or from the date that a post-trial motion is denied), then neither party shall again marry except to each other during the pendency of the appeal.

THIRD: That the costs of Court accrued herein are hereby taxed as paid. Defendant shall pay to Plaintiff the sum of \$5,000.00 for her attorney's fees, costs and expenses in prosecuting this matter. Judgment for this amount is hereby entered in favor of Plaintiff and against the Defendant.

FOURTH: The Defendant is enjoined from threatening to commit, or committing acts of abuse against the Plaintiff, and/or the children of the Plaintiff.

FIFTH: The Defendant is restrained and enjoined from harassing, stalking, annoying, threatening, engaging in conduct that would place the Plaintiff or her children in reasonable fear of bodily injury. The Defendant is restrained from and enjoined from contacting the Plaintiff and/or the children of the Plaintiff in any manner, either directly or indirectly.

SIXTH: The Defendant is restrained from having physical or violent contact with the Plaintiff or the Plaintiff's property, place of employment, school, and/or the children's residence, place of employment or school.

SEVENTH: The Defendant is ordered to stay away from any specified place, as designated below which the court determines the Defendant has no legitimate reason to frequent, frequented by the Plaintiff, children, and/or any designated person.

EIGHTH: The Defendant is ordered to not go within 1,000 feet of the Plaintiff, her residence, and/or her children's school, and/or place of employment.

NINTH: The Defendant is removed and excluded from the residence of the Plaintiff.
