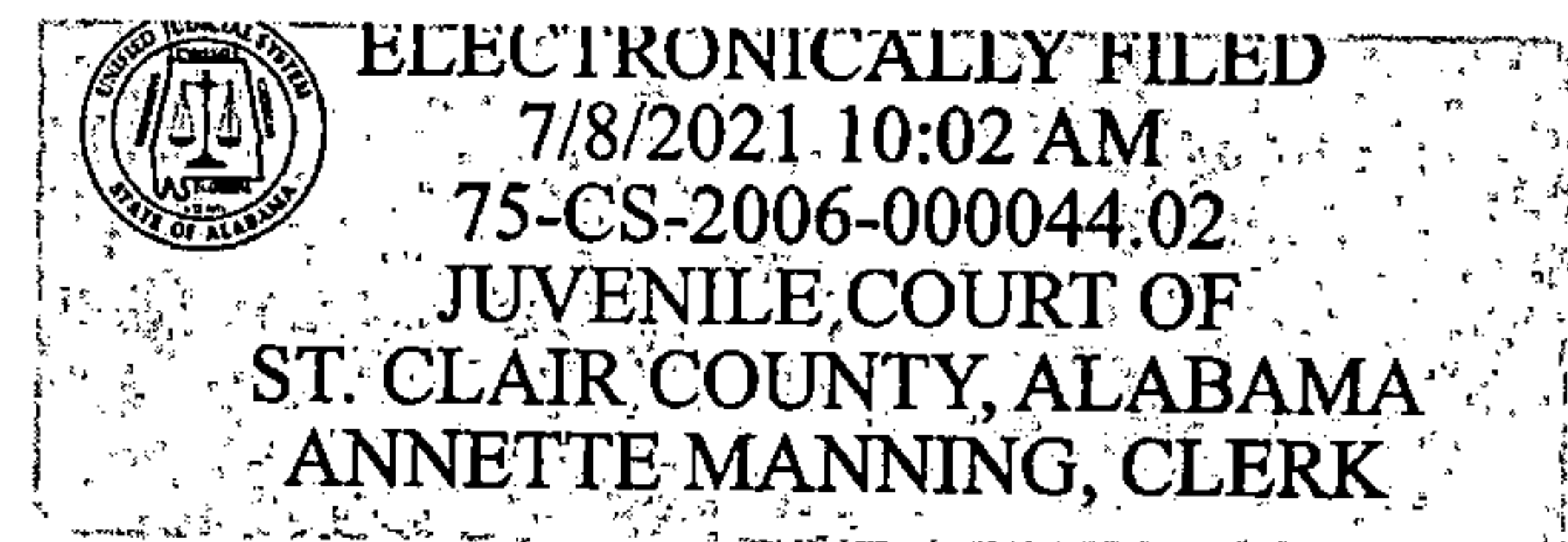

FINAL ORDER OF MODIFICATION

**THIS** case being called for trial on the 17<sup>th</sup> day of May 2021 on a Petition to Modify filed by the father 75-CS-2006-44.01 and A petition for Modification and Child Support, and Counterclaim for Contempt filed by the mother 75-CS-2006-000044.02. Present in court was the father, Travis Walton, represented by the Honorable Matt Gossett and the mother, Bridgett Beltzer, represented by the Honorable Stephanie Bain. The minor child was represented by her Guardian ad Litem, the Honorable Renay Bertella.

The attorneys and parties proffered to the court the issues of the case and the evidence of the case. This Honorable Court after hearing the evidence presented ruled upon said evidence. It is **ORDERED, ADJUDGED and DECREED** as follows,

It is **ORDERED**, an arrearage of child support as of the 17<sup>th</sup> day of May 2021 is **\$ 149,254.00** and the interest on said arrearage is in the amount of **\$117,154.95**. Total Child Support and interest owed by the father as of this date of this trial is **\$266,408.95**. Said amount shall be reduced to a judgment.

It is further **ORDERED** the father shall pay Three Thousand Dollars (**\$3,000.00**) in attorney fees directly to Stephanie Bain.

It is further **ORDERED** the father shall pay Two Thousand Dollars (**\$2,000.00**) and the mother shall pay Seven Hundred Seventy Five Dollars (**\$775.00**) in additional GAL fees directly to Renay Bertella.

It is further **ORDERED** the father shall pay One Thousand Nine Hundred Eighty Dollars and 65 cents (**\$1,980.65**) for back medical expenses and agrees to pay ½ of all future medical costs and ½ of the cost of the braces for the minor child.

It is further **ORDERED**, that the father shall pay the amount of One Thousand Dollars (\$1,000.00) monthly for the benefit of the minor child. The current support shall be in the amount of Six Hundred Fifty-Five Dollars (\$655.00) pursuant to the child support guidelines of Rule 32 A.R.J.A. Said amount shall be paid on the first day of each month beginning June 1<sup>st</sup>, 2021 and continue each month thereafter until said child reaches the age of majority, dies, or becomes self-supportive. The amount of Three Hundred Forty Five Dollars (\$345.00) shall be applied to said arrearage and interest. Said amount shall continue each month until said arrearage and interest are paid in full.

It is further **ORDERED**, that an *Order of Continuing Withholding for Support* pursuant to Code of Alabama 1975, Title 30-3-60 et seq., which shall be specifically incorporated herein as a part of the Court's Order and Decree in this cause; and said income withholding **SHALL BE** served.

It is further **ORDERED**, that the father shall visit with the minor child J.W. on the first Saturday of each month for a four (4) hour period at any place within the county in which the child resides, and any other times in which the parties may agree. The father shall pick up and deliver the child for said visitation. The mother and father shall work together to facilitate and encourage said visitation to take place.

All other aspects of the previous orders are to remain in full force and effect.
