Lot 4123, according to the Survey of Abingdon by the River as recorded in Map Book 53, page 43, in the Probate Office of Shelby County, Alabama.



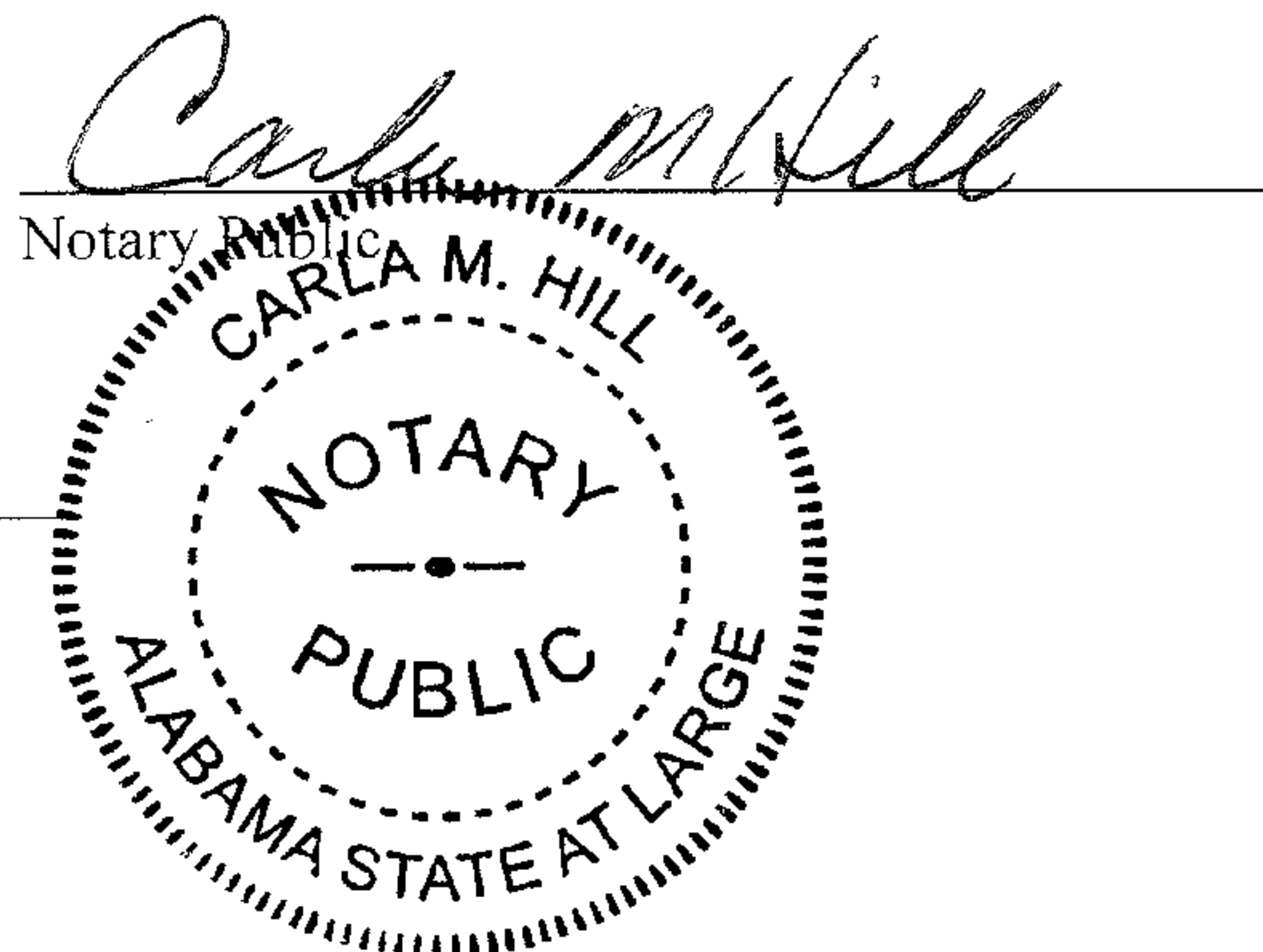
